# On the complexity of Putinar-Vasilescu's Positivstellensatz

#### Abstract

We provide a new degree bound on the weighted sum-of-squares (SOS) polynomials for Putinar-Vasilescu's Positivstellensatz. This leads to another Positivstellensatz saying that if $f$ is a polynomial of degree at most $2 d_{f}$ nonnegative on a semialgebraic set having nonempty interior defined by finitely many polynomial inequalities $g_{j}(x) \geq 0, j=1, \ldots, m$ with $g_{1}:=L-\|x\|_{2}^{2}$ for some $L>0$, then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{j}$ such that for any $\varepsilon>0$, for all $k \geq \bar{c} \varepsilon^{-c}, f$ has the decomposition $$
\begin{equation*} \left(1+\|x\|_{2}^{2}\right)^{k}(f+\varepsilon)=\sigma_{0}+\sum_{j=1}^{m} \sigma_{j} g_{j}, \tag{1} \end{equation*}
$$ for some SOS polynomials $\sigma_{j}$ being such that the degrees of $\sigma_{0}, \sigma_{j} g_{j}$ are at most $2\left(d_{f}+k\right)$. Here $\|\cdot\|_{2}$ denotes the $\ell_{2}$ vector norm. As a consequence, we obtain a converging hierarchy of semidefinite relaxations for lower bounds in polynomial optimization on basic compact semialgebraic sets. The complexity of this hierarchy is $\mathcal{O}\left(\varepsilon^{-c}\right)$ for prescribed accuracy $\varepsilon>0$. In particular, if $m=L=1$ then $c=65$, yielding the complexity $\mathcal{O}\left(\varepsilon^{-65}\right)$ for the minimization of a polynomial on the unit ball.

## 1 Introduction

For a positive $m \in \mathbb{N}$, let us consider the polynomial optimization problem (POP):

$$
\begin{equation*}
f^{\star}:=\inf _{x \in S} f(x) \tag{2}
\end{equation*}
$$

where $f \in \mathbb{R}[x]$ and

$$
\begin{equation*}
S:=\left\{x \in \mathbb{R}^{n}: g_{j}(x) \geq 0, j \in[m]\right\} \tag{3}
\end{equation*}
$$

for some $g_{j} \in \mathbb{R}[x], j \in[m]$. Here $\mathbb{R}[x]$ denotes the ring of real polynomials in vector of variables $x=\left(x_{1}, \ldots, x_{n}\right)$ and $[m]$ stands for the set $\{1, \ldots, m\}$. Assume that $f$ has degree at most $2 d_{f}$ for some positive $d_{f} \in \mathbb{N}$. The set $S$ is a conjunction of finitely many polynomial inequalities, and therefore is called a basic semialgebraic set.

Problem (2) can be written as

$$
\begin{equation*}
f^{\star}=\sup _{\lambda \in \mathbb{R}}\{\lambda: f-\lambda>0 \text { on } S\} . \tag{4}
\end{equation*}
$$

We can replace the inequality constraint of problem (4) by an equality constraint, if one can represent positive polynomials on $S$. Assume that $S$ has nonempty interior and a ball constraint is present, i.e., $g_{1}=L-\|x\|_{2}^{2}$ for some $L>0$. Our first (minor) contribution is to rely on the representation of polynomials positive on $S$ stated by Putinar and Vasilescu [17], to obtain

$$
\begin{equation*}
f-\lambda=\frac{\sigma_{0}+\sum_{j \in[m]} \sigma_{j} g_{j}}{\left(1+\|x\|_{2}^{2}\right)^{k}} \tag{5}
\end{equation*}
$$

for some $k \in \mathbb{N}, \sigma_{j} \in \Sigma[x], j \in[m]$, being such that $\operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right)$ and $\operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right)$. Here $\Sigma[x]$ denotes the set of sum-of-squares (SOS) polynomials and $\operatorname{deg}(\cdot)$ stands for the degree of a polynomial. Such a representation of positive polynomials is called a Positivstellensatz.

After bounding the degrees of the SOS polynomials involved in (5), we obtain the following hierarchy of relaxations indexed by $k \in \mathbb{N}$ :

$$
\begin{align*}
\rho_{k}^{(0)}:=\sup _{\lambda, \sigma_{j}} & \lambda \\
\text { s.t. } & \lambda \in \mathbb{R}, \sigma_{j} \in \Sigma[x]  \tag{6}\\
& \left(1+\|x\|_{2}^{2}\right)^{k}(f-\lambda)=\sigma_{0}+\sum_{j \in[m]} \sigma_{j} g_{j} \\
& \operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right), \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right)
\end{align*}
$$

Problem (6) can be solved numerically using semidefinite programming [1]. It is due to the fact that every SOS polynomial $\sigma$ of degree $2 t$ has the form $\sigma=v_{t}^{\top} G v_{t}$ for some positive semidefinite matrix $G$ (which is denoted by $G \succeq 0$, i.e., $G$ is symmetric and each eigenvalue of $G$ is nonnegative), with $v_{t}$ being the vector of all monomials $x^{\alpha}:=x_{1}^{\alpha_{1}} \ldots x_{n}^{\alpha_{n}}$ of degree at most $t$. Such a matrix $G$ is called a Gram matrix associated to $\sigma$. It is easy to see that for each $k \in \mathbb{N}, \rho_{k}^{(0)}$ is a lower bound of $f^{\star}$, that the sequence $\left(\rho_{k}^{(0)}\right)_{k \in \mathbb{N}}$ is monotone nondecreasing, and converges to $f^{\star}$.

In the present paper, we answer the following two interesting questions:

1. How fast does $\left(\rho_{k}^{(0)}\right)_{k \in \mathbb{N}}$ converge to $f^{\star}$ ? We show the convergence rate $\mathcal{O}\left(k^{-1 / c}\right)$ for some constant $c>0$ depending on $f$ and $g_{j}$.
2. Is there any explicit example to illustrate this rate of convergence? If $S$ is the unit ball, i.e., $m=1$ and $g_{1}=1-\|x\|_{2}^{2}$, the sequence $\left(\rho_{k}^{(0)}\right)_{k \in \mathbb{N}}$ converges to $f^{\star}$ with the rate $\mathcal{O}\left(k^{-1 / 65}\right)$.

### 1.1 Background

Positivity certificates have been studied throughout history of the development of real algebraic geometry. Nowadays it becomes a powerful tool for polynomial optimization thanks to the so-called Moment-SOS hierarchy (also known as "Lasserre's hierarchy") [8]. The convergence rate of the Moment-SOS hierarchy to the optimal value of a POP inherently depends on the complexity of the representation of positive polynomials. Roughly speaking, obtaining a lower degree bound on the SOS polynomials involved in the positivity certificate allows one to improve the convergence rate of the corresponding Moment-SOS hierarchy. How to find such lower degree bound is an interesting question and goes hand in hand with the quest of improving the convergence analysis of the Moment-SOS hierarchy. Let us review some of the standard results on degree bounds of positivity certificates and the corresponding convergence rates of the Moment-SOS hierarchy.

Reznick provides in [19] a Positivstellensatz for positive definite forms with an explicit degree bound. Namely, if $p$ is a positive definite form, i.e., $p$ is homogeneous and positive except at the origin, then for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \frac{2 n d(2 d-1)}{4 \log 2} \Theta(p)-\frac{n+2 d}{2}, \tag{7}
\end{equation*}
$$

then $\|x\|_{2}^{2 k} p$ is a homogeneous SOS polynomial of degree $2(k+d)$, where $2 d=\operatorname{deg}(p)$. Here for each $h \in \mathbb{R}[x]$,

$$
\begin{equation*}
\Theta(h):=\frac{\sup _{x \in \mathbb{S}^{n-1}} h(x)}{\inf _{x \in \mathbb{S}^{n-1}} h(x)} . \tag{8}
\end{equation*}
$$

This yields a linear convergence rate of $\mathcal{O}\left(\varepsilon^{-1}\right)$ for the minimization of a polynomial (see [9, Theorem 6]).

Powers and Reznick [15] improve the existing degree bound available for Pólya's Positivstellensatz [14]. Explicitly, if $p$ is a homogeneous polynomial of degree $d$ positive on the simplex

$$
\begin{equation*}
\Delta_{n}=\left\{x \in \mathbb{R}^{n}: x_{j} \geq 0, j \in[n], \sum_{j \in[n]} x_{j}=1\right\} \tag{9}
\end{equation*}
$$

then for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \frac{d(d-1)\|p\|}{2 \min _{x \in \Delta_{n}} p(x)}-d, \tag{10}
\end{equation*}
$$

$\left(\sum_{j \in[n]} x_{j}\right)^{k} p$ has positive coefficients. Here for each $h=\sum_{\alpha} h_{\alpha} x^{\alpha} \in \mathbb{R}[x]$, we note $\|h\|:=\max _{\alpha} \frac{\left|h_{\alpha}\right|}{c_{\alpha}}$ with $c_{\alpha}:=\frac{|\alpha|!}{\alpha_{1}!\ldots \alpha_{n}!}$ for each $\alpha \in \mathbb{N}^{n}$. This yields a linear convergence rate of $\mathcal{O}\left(\varepsilon^{-1}\right)$ for the minimization of a homogeneous polynomial on the simplex.

Applying the result of Powers and Reznick, Schweighofer [22] obtains a degree bound for Schmüdgen's Positivstellensatz [20] claiming that given a semialgebraic $S \subset(-1,1)^{n}$ defined as in (3) and a polynomial $f$ positive on $S$, then there exists a real $c>0$ depending on $S$ such that for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq c d_{f}^{2}\left(1+\left(d_{f}^{2} n^{d_{f}} \frac{\|f\|}{f^{\star}}\right)^{c}\right) \tag{11}
\end{equation*}
$$

one has $f \in \mathcal{P}_{k}$, where $\mathcal{P}_{k}$ is the truncated preordering of order $k \in \mathbb{N}$ associated with $S$ :

$$
\begin{equation*}
\mathcal{P}_{k}:=\left\{\sum_{\alpha \in\{0,1\}^{m}} \sigma_{\alpha} g_{1}^{\alpha_{1}} \ldots g_{m}^{\alpha_{m}}: \sigma_{\alpha} \in \Sigma[x], \operatorname{deg}\left(\sigma_{\alpha} g_{1}^{\alpha_{1}} \ldots g_{m}^{\alpha_{m}}\right) \leq k\right\} . \tag{12}
\end{equation*}
$$

Consequently, the corresponding SOS hierarchy of lower bounds $\left(\rho_{k}^{\text {pre }}\right)_{k \in \mathbb{N}}$, with

$$
\begin{equation*}
\rho_{k}^{\text {pre }}:=\sup _{\lambda \in \mathbb{R}}\left\{\lambda: f-\lambda \in \mathcal{P}_{k}\right\}, \quad k \in \mathbb{N}, \tag{13}
\end{equation*}
$$

converges to $f^{\star}$ with the rate $\mathcal{O}\left(\varepsilon^{-c}\right)$. Nevertheless, the representation of $f-\lambda$ in $\mathcal{P}_{k}$ involves $2^{m}$ SOS polynomials.

Relying on the degree bound for Schmüdgen's Positivstellensatz, Nie and Schweighofer analyze in [11] the complexity of Putinar's Positivstellensatz. Namely, if $S \subset(-1,1)^{n}$, $g_{1}=L-\|x\|_{2}^{2}$ for some $L>0$ and $f$ is positive on $S$, then there exists a real $c>0$ depending on $S$ such that for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq c \exp \left(\left(d_{f}^{2} n^{d_{f}} \frac{\|f\|}{f^{\star}}\right)^{c}\right) \tag{14}
\end{equation*}
$$

one has $f \in \mathcal{Q}_{k}$, where $\mathcal{Q}_{k}$ stands for the truncated quadratic module of order $k \in \mathbb{N}$ associated with $S$ :

$$
\begin{equation*}
\mathcal{Q}_{k}:=\left\{\sigma_{0}+\sum_{j \in[m]} \sigma_{j} g_{j}: \sigma_{j} \in \Sigma[x], \operatorname{deg}\left(\sigma_{0}\right) \leq k, \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq k\right\} \tag{15}
\end{equation*}
$$

Accordingly, the corresponding SOS hierarchy of lower bounds $\left(\rho_{k}^{\text {mod }}\right)_{k \in \mathbb{N}}$, with

$$
\begin{equation*}
\rho_{k}^{\bmod }:=\sup _{\lambda \in \mathbb{R}}\left\{\lambda: f-\lambda \in \mathcal{Q}_{k}\right\}, \quad k \in \mathbb{N}, \tag{16}
\end{equation*}
$$

converges to $f^{\star}$ with the rate $\mathcal{O}\left(\exp \left(\varepsilon^{-c}\right)\right)$. Despite of this exponential convergence rate, the representation of $f-\lambda$ in $\mathcal{Q}_{k}$ involves only $m+1$ SOS polynomials which is in deep contrast with the exponential number of SOS polynomials involved in the representation in $\mathcal{P}_{k}$.

However, the convergence rate of Schweighofer is still comparable to the later one of Nie-Schweighofer when the semialgebraic set $S$ is defined by $m_{1} \leq 1$ inequality constraints $g_{j}(x) \geq 0$ and $m_{2}$ equality constraints $h_{i}(x)=0$. In this case, it turn out that

$$
\begin{align*}
\rho_{k}^{\text {pre }}=\sup _{\lambda, \sigma_{j}, \eta_{i}} & \lambda \\
\text { s.t. } & \lambda \in \mathbb{R}, \sigma_{j} \in \Sigma[x], \eta_{i} \in \mathbb{R}[x]  \tag{17}\\
& f-\lambda=\sigma_{0}+\sum_{j \in\left[m_{1}\right]} \sigma_{j} g_{j}+\sum_{i \in\left[m_{2}\right]} \eta_{i} h_{i}, \\
& \operatorname{deg}\left(\sigma_{0}\right) \leq k, \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq k, \operatorname{deg}\left(\eta_{i} h_{i}\right) \leq k
\end{align*}
$$

and the sequence $\left(\rho_{k}^{\text {pre }}\right)_{k \in \mathbb{N}}$ converges to $f^{\star}$ with the rate $\mathcal{O}\left(\varepsilon^{-c}\right)$. Here $[0]=\emptyset$. In particular, $c=\frac{1}{2}$ when $f$ is homogeneous, $d_{f} \leq n, m_{1}=0$ and $m_{2}=1$ with $h_{1}=1-\|x\|_{2}^{2}$ as shown by Fang and Fawzi [4]. Thus they obtain the quadratic convergence rate $\mathcal{O}\left(k^{-2}\right)$ for the minimization of a homogeneous polynomial on the unit sphere. This improves upon the earlier linear convergence rate $\mathcal{O}\left(k^{-1}\right)$ by Doherty and Wehner in [3].

Recently Slot and Laurent [23] have provided several convergence rates for Lasserre's measure-based upper bounds for polynomial optimization, on specific convex domains and reference measures. This is in contrast with the present work, where we provide a new convergence rate for the Moment-SOS hierarchy of lower bounds for the minimization of a possibly nonconvex polynomial on a possibly nonconvex semialgebraic set.

Our contribution is concerned with the case of basic semialgebraic sets having nonempty interiors. Basically one obtains a convergence rate similar in spirit and magnitude of Schweighofer's bound $\bar{c} \varepsilon^{-c}$, but still based on the quadratic module $\mathcal{Q}_{k}$
(not the preordering $\mathcal{P}_{k}$ ) thanks to the prescribed denominator $\left(1+\|x\|_{2}^{2}\right)^{k}$ involved in Putinar-Vasilescu's Positivstellensatz.

Before showing explicitly our contribution, we restate the original result of Putinar and Vasilescu (without degree bound) in the following theorem:

Theorem 1. (Putinar-Vasilescu [18, Corollary 4.3 and 4.4]) Let $\theta$ be the quadratic polynomial $x \mapsto \theta(x):=1+\|x\|_{2}^{2}$, and denote by $\tilde{p} \in \mathbb{R}\left[x, x_{n+1}\right]$ the homogeneous polynomial associated with $p \in \mathbb{R}[x]$, defined by $x \mapsto \tilde{p}(x):=x_{n+1}^{\operatorname{deg}(p)} p\left(x / x_{n+1}\right)$.

1. Let $f \in \mathbb{R}[x]$ such that $\tilde{f}>0$ on $\mathbb{R}^{n+1} \backslash\{0\}$. Then $\theta^{k} f \in \Sigma[x]$ for some $k \in \mathbb{N}$.
2. Let $f, g_{1}, \ldots, g_{m} \in \mathbb{R}[x]$ satisfy the following two conditions:
(a) $f=f_{0}+f_{1}$ such that $\operatorname{deg}\left(f_{0}\right)<\operatorname{deg}\left(f_{1}\right)$ and $\tilde{f}_{1}>0$ on $\mathbb{R}^{n+1} \backslash\{0\}$;
(b) $f>0$ on $S=\left\{x \in \mathbb{R}^{n}: g_{j}(x) \geq 0, j \in[m]\right\}$.

Then $\theta^{2 k} f \in \cup_{r=1}^{\infty} \mathcal{Q}_{r}$ for some $k \in \mathbb{N}$, where $\mathcal{Q}_{r}$ is defined as in (15).

### 1.2 Contribution

The construction of the hierarchy of semidefinite relaxations (6) is based on the Positivstellensatz stated in Corollary 2. More explicitly, if $S$ has nonempty interior such that $g_{1}=L-\|x\|_{2}^{2}$ for some $L>0$ and $f$ is of degree at most $2 d_{f}$ such that $f$ is nonnegative on $S$, then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{j}$ such that for all $\varepsilon>0$, for all $k \geq \bar{c} \varepsilon^{-c}$,

$$
\begin{equation*}
\left(1+\|x\|_{2}^{2}\right)^{k}(f+\varepsilon)=\sigma_{0}+\sum_{j \in[m]} \sigma_{j} g_{j} \tag{18}
\end{equation*}
$$

for some $\sigma_{j} \in \Sigma[x]$ being such that $\operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right)$ and $\operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right)$.
In order to prove (18), we provide a degree bound on the weighted SOS polynomials for the homogenized Putinar-Vasilescu's Positivstellensatz [17]. This is stated in Theorem 2 as follows: If $f, g_{1}, \ldots, g_{m}$ are homogeneous polynomials of even degrees such that $S$ has nonempty interior and $f$ is nonnegative on $S$, then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{j}$ such that for all $\varepsilon>0$, for all $k \geq \bar{c} \varepsilon^{-c}$,

$$
\begin{equation*}
\|x\|_{2}^{2 k}\left(f+\varepsilon\|x\|_{2}^{2 d_{f}}\right)=\sigma_{0}+\sum_{j \in[m]} \sigma_{j} g_{j} \tag{19}
\end{equation*}
$$

for some homogeneous SOS polynomials $\sigma_{j}$ being such that $\operatorname{deg}\left(\sigma_{0}\right)=\operatorname{deg}\left(\sigma_{j} g_{j}\right)=$ $2\left(k+d_{f}\right)$. Here a polynomial $p$ is homogeneous of degree $2 t$ if $p(\lambda x)=\lambda^{2 t} p(x)$ for all $x \in \mathbb{R}^{n}$ and each $\lambda \in \mathbb{R}$. Remark that the original version of Putinar-Vasilescu's Positivstellensatz in [17] does not include any degree bound on the weighted SOS polynomials $\sigma_{j}$ involved in the representation (19). Our proof of Theorem 2 consists of three main steps:

1. Construct iteratively some positive "weight" functions $\psi_{j}$ such that $f+\varepsilon-$ $\sum_{j \in[m]} \psi_{j} g_{j}$ is positive on $[-1,1]^{n}$. The idea of this step is similar in spirit to the proof of the inductive property in [21, Proposition 3.1] and relies on the Lojasiewicz inequality.
2. Approximate $\sqrt{\psi_{j}}$ with the multivariate Bernstein polynomial $q_{j}$ on $[-1,1]^{n}$ such that the polynomial $H=f+\varepsilon-\sum_{j \in[m]} q_{j}^{2} g_{j}$ is positive on the unit sphere $\mathbb{S}^{n-1}$.
3. Apply Reznick's Positivstellensatz [19] to the homogenization of $H$. The complexity analysis of every step is derived to get the final degree bound $\bar{c} \varepsilon^{-c}$.

Afterwards, we obtain in Corollary 1 the same degree bound for the dehomogenized Putinar-Vasilescu's Positivstellensatz. This improves the bound $\mathcal{O}\left(\exp \left(\varepsilon^{-c}\right)\right)$ obtained in our previous work [9], based on Nie-Schweighofer's complexity result [11] for Putinar's Positivstellensatz [16]. Corollary 1 yields the convergence rate $\mathcal{O}\left(\varepsilon^{-c}\right)$ for the corresponding hierarchy of relaxations for polynomial optimization on general (not necessarily compact) basic semialgebraic sets.

### 1.3 Technical insights

We start to recall the two main steps in the proof of Nie and Schweighofer [11] for the degree bound of SOS polynomials involved in Putinar's Positivstellensatz:

1. Find a large enough $k \in \mathbb{N}$ such that the polynomial

$$
\begin{equation*}
F=f+\varepsilon-\lambda \sum_{j \in[m]}\left(g_{j}-1\right)^{2 k} g_{j} \tag{20}
\end{equation*}
$$

is positive on $[-1,1]^{n}$. An estimate $k \geq O\left(\varepsilon^{-c}\right)$ is obtained. Here $\varepsilon>0$ measures how close the polynomial $f$ (assumed to be nonnegative on $S$ ) is to have a zero on $S$.
2. Apply Schmüdgen's Positivstellensatz to $F$ on $[-1,1]^{n}$.

Notice that Schweighofer's degree bound of Schmüdgen's Positivstellensatz is exponential in the degree of the given positive polynomial ( $n^{d_{f}}$ in (11)). Accordingly, Nie and Schweighofer obtain an exponential bound $n^{\mathcal{O}\left(\varepsilon^{-c}\right)}$ in the second step since $\operatorname{deg}(F) \sim C k$ as $k \rightarrow \infty$ for some positive constant $C$.

One notable difference in our proof is that the weight $\lambda\left(g_{j}-1\right)^{k}$ in (20) is replaced by a non-differentiable positive function $\psi_{j}$. Surprisingly, we can prove that the square root $\sqrt{\psi_{j}}$ is a Lipschitz continuous function. Thus each $\sqrt{\psi_{j}}$ can be approximated with a Bernstein polynomials $q_{i}$ on $[-1,1]$. Here, the advantage of using Bernstein polynomials is that the approximation error between $\sqrt{\psi_{j}}$ and $q_{i}$ decreases with a rate which only depends on a Lipschitz constant of $\sqrt{\psi_{j}}$, and $\left|q_{i}\right|$ is upper bounded by the supremum of $\sqrt{\psi_{j}}$ on $[-1,1]^{n}$.

Next, we apply Reznick's Positivstellensatz to the homogeneous polynomial $\tilde{H}$ obtained from the homogenization of

$$
\begin{equation*}
H:=f+\varepsilon-\sum_{j \in[m]} q_{j}^{2} g_{j} \tag{21}
\end{equation*}
$$

being such that the bounds of $\tilde{H}$ and $H$ on the unit sphere are the same. The important point to note here is that the degree bound of Reznick's Positivstellensatz is quadratic in the degree of $\tilde{H}$ and linear in the ratio $\Theta(\tilde{H})$ (see (7)). This is in deep contrast with Schmüdgen's Positivstellensatz, as there is no exponential dependency in these two quantities. This leads to the difference between our convergence rate $\mathcal{O}\left(\varepsilon^{-c}\right)$ and Nie-Schweighofer's rate $\mathcal{O}\left(\exp \left(\varepsilon^{-c}\right)\right)$.

One may ask whether with the same techniques from our proof, one could improve the existing degree bound for Putinar's Positivstellensatz. We have tried to apply the degree bound (10) of Pólya's Positivstellensatz to $H$ after a change of coordinate, but unfortunately this leads to the same bound as Nie and Schweighofer. The underlying reason is that the norm $\|p\|$ in (10) depends on the coefficients of $p$. In our situation, $p$ coincides with $H$ and the coefficients of $H$ are bounded by a value involving the coefficients of the Bernstein polynomials. The bound on the largest coefficient, even for a univariate Bernstein polynomial, seems to be exponential in the approximation order $t$, namely, $\binom{2 t}{t} \sim \frac{4^{t}}{\sqrt{\pi t}}$ as $t \rightarrow \infty$. The same issue occurs when we apply the degree bound of Schmüdgen's Positivstellensatz instead of the one of Pólya's Positivstellensatz.

## 2 Notation and definitions

In this section, we introduce mandatory notation and definitions. With $x:=$ $\left(x_{1}, \ldots, x_{n}\right)$, let $\mathbb{R}[x]$ stand for the ring of real polynomials and let $\Sigma[x] \subset \mathbb{R}[x]$ be the subset of sum-of-squares (SOS) of polynomials. Let us note $\mathbb{R}[x]_{t}$ and $\Sigma[x]_{t}$ the respective restrictions of these two sets to polynomials of degree at most $t$ and $2 t$.

Given $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in \mathbb{N}^{n}$, we note $|\alpha|:=\alpha_{1}+\cdots+\alpha_{n}$. Denote $\mathbb{N}_{t}^{n}=\{\alpha \in$ $\left.\mathbb{N}^{n}:|\alpha| \leq t\right\}$ for each $t \in \mathbb{N}$. Let $\left(x^{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$ be the canonical basis of monomials
for $\mathbb{R}[x]$ (ordered according to the graded lexicographic order) and $v_{t}(x)$ be the vector of all monomials up to degree $t$, with length $\binom{n+t}{n}$. A polynomial $f \in \mathbb{R}[x]_{t}$ is written as $f(x)=\sum_{|\alpha| \leq t} f_{\alpha} x^{\alpha}=\bar{f}^{\top} v_{t}(x)$, where $\bar{f}:=\left(f_{\alpha}\right)_{\alpha} \in \mathbb{R}^{\binom{n+t}{n}}$ is its vector of coefficients in the canonical basis. The degree-t homogenization $\tilde{f}$ associated to $f \in \mathbb{R}[x]_{t}$ is a homogeneous polynomial of degree $t$ in $n+1$ variables, defined by $\tilde{f}\left(x, x_{n+1}\right):=x_{n+1}^{t} f\left(x / x_{n+1}\right)$. A positive definite form is a nonnegative homogeneous polynomial which is positive everywhere except at the origin.

For a given real-valued sequence $y=\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$, let us define the Riesz linear functional $L_{y}: \mathbb{R}[x] \rightarrow \mathbb{R}$ by $f \mapsto L_{y}(f):=\sum_{\alpha} f_{\alpha} y_{\alpha}$, for all $f \in \mathbb{R}[x]$. We say that a real infinite (resp. finite) sequence $\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$ (resp. $\left.\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}_{t}^{n}}\right)$ has a representing measure if there exists a finite Borel measure $\mu$ such that $y_{\alpha}=\int_{\mathbb{R}^{n}} x^{\alpha} d \mu(x)$ is satisfied for every $\alpha \in \mathbb{N}^{n}$ (resp. $\alpha \in \mathbb{N}_{t}^{n}$ ). In this case, $\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$ is called the moment sequence of $\mu$. Next, given $y=\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}^{n}}$ and $d \in \mathbb{N}^{*}$, the moment matrix $M_{d}(y)$ of degree $d$ associated to $y$ is the real symmetric matrix of size $\binom{n+d}{d}$ defined by $M_{d}(y):=\left(y_{\alpha+\beta}\right)_{\alpha, \beta \in \mathbb{N}_{d}^{n}}$. Let $g=\sum_{\gamma} g_{\gamma} x^{\gamma} \in \mathbb{R}[x]$. The localizing matrix $M_{d}(g y)$ of degree $d$ associated with $y$ and $g$ is the real symmetric matrix of the size $\binom{n+d}{d}$ given by $M_{d}(g y):=\left(\sum_{\gamma} g_{\gamma} y_{\gamma+\alpha+\beta}\right)_{\alpha, \beta \in \mathbb{N}_{d}^{n}}$.

## 3 Representation theorems and degree bounds

In this section, we derive representations of polynomials nonnegative on semialgebraic sets together with degree bounds. We extend these representations to the set of continuous functions being nonnegative on compact domains.

### 3.1 Polynomials nonnegative on general semialgebraic sets

We analyze the complexity of Putinar-Vasilescu's Positivstellensatz [17] in the following theorem:

Theorem 2. (Homogenized representation) Let $g_{1}, \ldots, g_{m}$ be homogeneous polynomials of even degrees such that the semialgebraic set

$$
\begin{equation*}
S:=\left\{x \in \mathbb{R}^{n}: g_{1}(x) \geq 0 \ldots, g_{m}(x) \geq 0\right\} \tag{22}
\end{equation*}
$$

has nonempty interior. Let $f$ be a homogeneous polynomial of degree $2 d_{f}$ for some $d_{f} \in \mathbb{N}$ such that $f$ is nonnegative on $S$. Then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for all $\varepsilon>0$, for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \bar{c} \varepsilon^{-c}, \tag{23}
\end{equation*}
$$

there exist homogeneous SOS polynomials $\sigma_{0}, \ldots, \sigma_{m}$ such that

$$
\begin{equation*}
\operatorname{deg}\left(\sigma_{0}\right)=\operatorname{deg}\left(\sigma_{1} g_{1}\right)=\cdots=\operatorname{deg}\left(\sigma_{m} g_{m}\right)=2\left(k+d_{f}\right) \tag{24}
\end{equation*}
$$

and

$$
\begin{equation*}
\|x\|_{2}^{2 k}\left(f+\varepsilon\|x\|_{2}^{2 d_{f}}\right)=\sigma_{0}+\sigma_{1} g_{1}+\cdots+\sigma_{m} g_{m} \tag{25}
\end{equation*}
$$

In particular, if $m=1$ and $g_{1}=x_{n}^{2}-\left\|x^{\prime}\right\|_{2}^{2}$ with $x^{\prime}:=\left(x_{1}, \ldots, x_{n-1}\right)$, then $c=65$. Moreover, each SOS polynomial $\sigma_{i}$ involved in (25) can be chosen as the (single) square of a homogeneous polynomial, for $i \in[m]$.

The proof of Theorem 2 is postponed to Subsection 3.4. In Theorem 2, all polynomials are assumed to have even degrees. Next, we provide two corollaries where each polynomial can have odd degree.

The following corollary is a direct consequence of Theorem 2.

Corollary 1. (Dehomogenized representation) Let $g_{1}, \ldots, g_{m}$ be polynomials such that the semialgebraic set

$$
\begin{equation*}
S:=\left\{x \in \mathbb{R}^{n}: g_{1}(x) \geq 0 \ldots, g_{m}(x) \geq 0\right\} \tag{26}
\end{equation*}
$$

has nonempty interior. Let $f$ be a polynomial nonnegative on $S$. Denote $d_{f}:=$ $\lfloor\operatorname{deg}(f) / 2\rfloor+1$. Then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for all $\varepsilon>0$, for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \bar{c} \varepsilon^{-c}, \tag{27}
\end{equation*}
$$

there exist SOS polynomials $\sigma_{0}, \ldots, \sigma_{m}$ such that

$$
\begin{equation*}
\operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right) \quad \text { and } \quad \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right), j=1, \ldots, m, \tag{28}
\end{equation*}
$$

and

$$
\begin{equation*}
\theta^{k}\left(f+\varepsilon \theta^{d_{f}}\right)=\sigma_{0}+\sigma_{1} g_{1}+\cdots+\sigma_{m} g_{m} \tag{29}
\end{equation*}
$$

where $\theta:=1+\|x\|_{2}^{2}$. Moreover, if $m=1$ and $g_{1}=1-\|x\|_{2}^{2}$, then $c=65$.
Proof. The proof of Corollary 1 is similar to the proof of [9, Theorems 4 and 5]. We recall the basic ingredients. Let $\tilde{S}$ be a homogenized version of $S$, defined by

$$
\begin{equation*}
\tilde{S}:=\left\{\left(x, x_{n+1}\right) \in \mathbb{R}^{n+1}: \tilde{g}_{j}\left(x, x_{n+1}\right) \geq 0, j \in[m]\right\} \tag{30}
\end{equation*}
$$

with $\tilde{g}_{j}\left(x, x_{n+1}\right):=x_{n+1}^{2 d_{g_{j}}} g_{j}\left(x / x_{n+1}\right)$ being the degree- $2 d_{g_{j}}$ homogenization of $g_{j}$ and $d_{g_{j}}:=\left\lceil\operatorname{deg}\left(g_{j}\right) / 2\right\rceil$, for $j \in[m]$. Then the proof consists of three steps:

1. Prove that the degree- $2 d_{f}$ homogenization of $f$, denoted by $\tilde{f}$, is nonnegative on $\tilde{S}$.
2. Use Theorem 2 to obtain a representation of $\tilde{f}$ together with the degree bound on SOS polynomials.
3. Obtain a representation of $f$ by evaluating the representation of $\tilde{f}$ at $x_{n+1}=1$. To apply Theorem 2, we need to show that if $S$ has nonempty interior, then $\tilde{S}$ has nonempty interior. This statement holds since when $a$ belongs to the interior of $S$, one has $\tilde{g}_{j}(a, 1)=g_{j}(a)>0$, implying that $(a, 1)$ belongs to the interior of $\tilde{S}$.

Note that the ice cream constraint $x_{n+1}^{2}-\|x\|_{2}^{2}$ is the degree- 2 homogenization associated to the ball constraint $1-\|x\|_{2}^{2}$.

### 3.2 Polynomials nonnegative on compact semialgebraic sets

The following corollary is deduced from Corollary 1.
Corollary 2. Let $g_{1}, \ldots, g_{m}$ be polynomials such that $g_{1}:=L-\|x\|_{2}^{2}$ for some $L>0$ and the semialgebraic set

$$
\begin{equation*}
S:=\left\{x \in \mathbb{R}^{n}: g_{1}(x) \geq 0 \ldots, g_{m}(x) \geq 0\right\} \tag{31}
\end{equation*}
$$

has nonempty interior. Let $f$ be a polynomial nonnegative on $S$. Denote $d_{f}:=$ $\lfloor\operatorname{deg}(f) / 2\rfloor+1$. Then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for all $\varepsilon>0$, for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \bar{c} \varepsilon^{-c} \tag{32}
\end{equation*}
$$

there exist SOS polynomials $\sigma_{0}, \ldots, \sigma_{m}$ such that

$$
\begin{equation*}
\operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right) \quad \text { and } \quad \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right), j=1, \ldots, m \tag{33}
\end{equation*}
$$

and

$$
\begin{equation*}
\left(1+\|x\|_{2}^{2}\right)^{k}(f+\varepsilon)=\sigma_{0}+\sigma_{1} g_{1}+\cdots+\sigma_{m} g_{m} \tag{34}
\end{equation*}
$$

Moreover, if $m=1$ and $L=1$, then $c=65$.

Proof. By using Corollary 1, there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for all $\varepsilon>0$, for all $k \in \mathbb{N}$ satisfying $k \geq \bar{c} \varepsilon^{-c}$, there exist SOS polynomials $\sigma_{0}, \ldots, \sigma_{m}$ such that

$$
\begin{equation*}
\operatorname{deg}\left(\sigma_{0}\right) \leq 2\left(k+d_{f}\right) \quad \text { and } \quad \operatorname{deg}\left(\sigma_{j} g_{j}\right) \leq 2\left(k+d_{f}\right), j=1, \ldots, m \tag{35}
\end{equation*}
$$

and

$$
\begin{equation*}
\theta^{k}\left(f+\varepsilon \theta^{d_{f}}\right)=\sigma_{0}+\sigma_{1} g_{1}+\cdots+\sigma_{m} g_{m} \tag{36}
\end{equation*}
$$

where $\theta:=1+\|x\|_{2}^{2}$. In addition,

$$
\begin{equation*}
(L+1)^{d_{f}}-\theta^{d_{f}}=\left(L-\|x\|_{2}^{2}\right) \sum_{j=0}^{d_{f}-1}(L+1)^{d_{f}-1-j} \theta^{j}=s_{1} g_{1}, \tag{37}
\end{equation*}
$$

where $s_{1}=\sum_{j=0}^{d_{f}-1}(L+1)^{d_{f}-1-j} \theta^{j}$ is an SOS polynomial of degree $2\left(d_{f}-1\right)$. From this,

$$
\begin{align*}
\theta^{k}\left[f+\varepsilon(L+1)^{d_{f}}\right] & =\theta^{k}\left(f+\varepsilon \theta^{d_{f}}\right)+\varepsilon \theta^{k}\left[(L+1)^{d_{f}}-\theta^{d_{f}}\right] \\
& =\sigma_{0}+\left(\varepsilon s_{1} \theta^{k}+\sigma_{1}\right) g_{1}+\sum_{j=2}^{m} \sigma_{j} g_{j}, \tag{38}
\end{align*}
$$

which yields the desired result.

Remark 1. In Corollary 2, if $m=1$ and $L>0$, we still obtain $c=65$. Indeed, up to a scaling, one can always assume $L=1$.

Remark 2. We can apply the technique used in the proof of Corollary 2, which consists of replacing the perturbation $\varepsilon \theta^{d_{f}}$ by $\varepsilon$, to represent polynomials nonnegative on $\mathbb{R}^{n}$. Let us consider an arbitrary large positive constant $L$ and a polynomial $f$ of degree $2 d_{f}$ which is nonnegative on $\mathbb{R}^{n}$. Then, thanks to [9, Theorem 3.2], for any $\varepsilon>0$, for all $k \in \mathbb{N}$ such that $k \geq \mathcal{O}\left(\varepsilon^{-1}\right), \theta^{k}\left(f+\varepsilon \theta^{d_{f}}\right)$ is an SOS polynomial, so that $\theta^{k}(f+\varepsilon)=\sigma_{0}+\sigma_{1}\left(L-\|x\|_{2}^{2}\right)$ for some SOS polynomials $\sigma_{i}, i=0,1$. This is the so-called "big ball trick". This representation yields a linear convergence rate $\mathcal{O}\left(\varepsilon^{-1}\right)$ for the minimization of polynomials on $\mathbb{R}^{n}$.

### 3.3 Preliminary material

This subsection presents some important lemmas that we use to prove the main results.

Given $\Omega \subset \mathbb{R}^{n}$, the distance of $a \in \mathbb{R}^{n}$ to $\Omega$ is denoted by $\operatorname{dist}(a, \Omega)$. Denote by $B(a, r)$ (resp. $\left.B^{\circ}(a, r)\right)$ the closed (resp. open) ball centered at $a \in \mathbb{R}^{n}$ with radius $r>0$.

We recall the Lojasiewicz inequality in the following lemma:
Lemma 1. Let $g: U \rightarrow \mathbb{R}$ be an analytic function on an open set $U \subset \mathbb{R}^{n}$ and $Z:=\{x \in K: g(x)=0\}$ for some compact set $K \subset U$. Then there exists $\alpha>0$ and $C>0$ such that

$$
d(x, Z)^{\alpha} \leq C|g(x)|, \forall x \in K .
$$

As a consequence of Lemma 1, we obtain the following result:
Lemma 2. ( [2, Corollary 2.6.7]) Let $r>0$ and the semialgebraic set $S:=\{x \in$ $\left.\mathbb{R}^{n}: g_{j}(x) \geq 0, j \in[m]\right\}$, where $g_{1}, \ldots, g_{m}$ are polynomials. Then there exist positive constants $\alpha$ and $C$ such that, for all $x$ in $B(0, r)$,

$$
\begin{equation*}
\operatorname{dist}(x, S)^{\alpha} \leq-C \min \left\{g_{1}(x), \ldots, g_{m}(x), 0\right\} \tag{39}
\end{equation*}
$$

Given an open set $U \subset \mathbb{R}^{n}$ and a differentiable function $\varphi: U \rightarrow \mathbb{R}$, denote by $\nabla \varphi(x)=\left[\partial_{x_{1}} \varphi(x), \ldots, \partial_{x_{n}} \varphi(x)\right]$ the gradient of $\varphi$ at $x \in U$. Given $x=\left(x_{1}, \ldots, x_{n}\right) \in$ $\mathbb{R}^{n}$, let $x^{\prime}:=\left(x_{1}, \ldots, x_{n-1}\right)$.

As mentioned in [13, Theorem 3.8], one can prove that $\alpha \in\{1,2\}$ in Lemma 1 if $g$ is a quadratic polynomial. The following lemma states an instance of this result:

Lemma 3. (Eojasiewicz inequality with ice cream constraint) Let $g:=x_{n}^{2}-\left\|x^{\prime}\right\|_{2}^{2}$ and $Z:=\left\{x \in \mathbb{R}^{n}: g(x)=0\right\}$. Then for all $x \in \mathbb{R}^{n}$,

$$
\begin{equation*}
\operatorname{dist}(x, Z)^{2} \leq \frac{|g(x)|}{2} \tag{40}
\end{equation*}
$$

Proof. If $x \in Z$, both sides of (40) are zeros. Let $x \in \mathbb{R}^{n} \backslash Z$ be fixed. Then $d(x, Z)^{2}=\min _{y}\left\{\|x-y\|_{2}^{2}: g(y)=0\right\}$. Assume that $(y, \mu) \in \mathbb{R}^{n} \times \mathbb{R}$ satisfies the Karush-Kuhn-Tucker conditions:

$$
\left\{\begin{array}{l}
\nabla_{y}\|x-y\|_{2}^{2}=\mu \nabla_{y} g(y)  \tag{41}\\
g(y)=0
\end{array}\right.
$$

The first condition of (41) implies that $2(x-y)=\mu\left[\begin{array}{c}-2 y^{\prime} \\ 2 y_{n}\end{array}\right]$, so $x^{\prime}-y^{\prime}=-\mu y^{\prime}$ and $x_{n}-y_{n}=\mu y_{n}$. Assume that $\mu \notin\{1,-1\}$. Then $y^{\prime}=\frac{x^{\prime}}{1-\mu}$ and $y_{n}=\frac{x_{n}}{1+\mu}$. Since $g(y)=y_{n}^{2}-\left\|y^{\prime}\right\|_{2}^{2}=0, y_{n}= \pm\left\|y^{\prime}\right\|_{2}$.

Let us consider the first case $y_{n}=\left\|y^{\prime}\right\|_{2}$. Then $\frac{x_{n}}{1+\mu}=\frac{\left\|x^{\prime}\right\|_{2}}{1-\mu}$. It implies that $\mu=\frac{x_{n}-\left\|x^{\prime}\right\|_{2}}{x_{n}+\left\|x^{\prime}\right\|_{2}}$. Note that $x_{n} \neq-\left\|x^{\prime}\right\|_{2}$ since $g(x) \neq 0$. From this, $y^{\prime}=\frac{\left(x_{n}+\left\|x^{\prime}\right\|_{2}\right) x^{\prime}}{2\left\|x^{\prime}\right\|_{2}}$ and $y_{n}=\frac{x_{n}+\left\|x^{\prime}\right\|_{2}}{2}$. Thus, $\|x-y\|_{2}^{2}=\frac{\left(x_{n}-\left\|x^{\prime}\right\|_{2}\right)^{2}}{2}$.

Similarly, if we consider the case $y_{n}=-\left\|y^{\prime}\right\|_{2}$, then $\|x-y\|_{2}^{2}=\frac{\left(x_{n}+\left\|x^{\prime}\right\|_{2}\right)^{2}}{2}$.
Let us consider the case of $\mu \in\{1,-1\}$. Assume that $\mu=1$. Then $x^{\prime}=0$ and $y_{n}=\frac{x_{n}}{2}$. From this and the fact that $0=g(y)=y_{n}^{2}-\left\|y^{\prime}\right\|_{2}^{2}$, we obtain $\left\|y^{\prime}\right\|_{2}^{2}=\frac{x_{n}^{2}}{4}$. It implies that $\|x-y\|_{2}^{2}=\left\|y^{\prime}\right\|_{2}^{2}+\left(x_{n}-y_{n}\right)^{2}=\frac{x_{n}^{2}}{4}+\frac{x_{n}^{2}}{4}=\frac{x_{n}^{2}}{2}=\frac{\left(x_{n}-\left\|x^{\prime}\right\|_{2}\right)^{2}}{2}$. Thus, $\|x-y\|_{2}^{2}=\frac{\left(x_{n}-\left\|x^{\prime}\right\|_{2}\right)^{2}}{2}$.

Similarly, if we consider the case $\mu=-1$, then $\|x-y\|_{2}^{2}=\frac{\left(x_{n}+\left\|x^{\prime}\right\|_{2}\right)^{2}}{2}$.
Thus,

$$
\begin{align*}
d(x, Z)^{2} & \leq \frac{1}{2} \min \left\{\left(x_{n}-\left\|x^{\prime}\right\|_{2}\right)^{2},\left(x_{n}+\left\|x^{\prime}\right\|_{2}\right)^{2}\right\}  \tag{42}\\
& \leq \frac{1}{2} \sqrt{\left(x_{n}-\left\|x^{\prime}\right\|_{2}\right)^{2}\left(x_{n}+\left\|x^{\prime}\right\|_{2}\right)^{2}} \\
& =\frac{1}{2}\left|x_{n}^{2}-\left\|x^{\prime}\right\|_{2}^{2}\right|=\frac{|g(x)|}{2},
\end{align*}
$$

yielding (40).
A real-valued function $f: U \rightarrow \mathbb{R}$ for some $U \subset \mathbb{R}^{n}$ is called $L$-Lipschitz (or Lipschitz) continuous on $K \subset U$ if there exits a real $L>0$ such that $|f(x)-f(y)| \leq$ $L\|x-y\|_{2}$, for all $x, y \in K$. In this case, $L$ is called the Lipschitz constant of $f$ on $K$. Given an open set $U \subset \mathbb{R}^{n}$, a function $f: U \rightarrow \mathbb{R}$ is called locally Lipschitz continuous on $K \subset U$ if for every $x \in K$ there exists a neighborhood $W \subset U$ of $x$ such that $f$ is Lipschitz continuous on $W \cap K$.

The following lemma is similar in spirit to [12, Section 2.4, Lemma 2]:
Lemma 4. Given an open set $U \subset \mathbb{R}^{n}$, if the function $f: U \rightarrow \mathbb{R}$ is locally Lipschitz on a compact set $K \subset U$, then $f$ is Lipschitz on $K$.

Proof. Since $f$ is locally Lipschitz on $K$, for each $x \in K$ there is some $r_{x}>0$ and $L_{x}>0$ such that $B\left(x, r_{x}\right) \subset U$ and $f$ is $L_{x}$-Lipschitz on $B\left(x, r_{x}\right) \cap K$. Then the sets $B\left(x, \frac{1}{2} r_{x}\right), x \in K$ form an open cover of $K$. Due to the compactness of $K$, there exists a finite subsequence of $B\left(x, \frac{1}{2} r_{x}\right), x \in K$ covering $K$. For convenience, denote these
by $B\left(x_{k}, \frac{1}{2} r_{k}\right)$ and $L_{k}:=L_{x_{k}}, k \in[l]$. Let $M:=\sup _{x \in K}|f(x)|, r:=\frac{1}{2} \min _{k \in[l]} r_{k}$, $L_{0}:=\frac{2 M}{r}$ and $L:=\max \left\{L_{0}, L_{k}: k \in[l]\right\}$. Then $L$ is a Lipschitz constant of $f$ on $K$. To see this, pick $x, y \in K$. If $\|x-y\|_{2} \geq r$ then we see that $\frac{|f(x)-f(y)|}{\|x-y\|_{2}} \leq \frac{2 M}{r}=L_{0} \leq L$. If $\|x-y\|_{2}<r$, then for some $x_{k}$ we have $x \in B\left(x_{k}, \frac{1}{2} r_{k}\right)$. Then $y \in B\left(x_{k}, r_{k}\right)$ and so $|f(x)-f(y)| \leq L_{k}\|x-y\|_{2} \leq L\|x-y\|_{2}$.

Lemma 5. (Kirszbraun's theorem [7]) If $U$ is a subset of $\mathbb{R}^{n}$ and $f: U \rightarrow \mathbb{R}$ is a Lipschitz continuous function, then there is a Lipschitz continuous function $F: \mathbb{R}^{n} \rightarrow$ $\mathbb{R}$ that extends $f$ and has the same Lipschitz constant as $f$. Moreover the extension is provided by

$$
\begin{equation*}
F(x):=\inf _{u \in U}\left\{f(u)+L_{f}\|x-u\|_{2}\right\} \tag{43}
\end{equation*}
$$

where $L_{f}$ is the Lipschitz constant of $f$ on $U$.
Given $\Omega \subset \mathbb{R}^{n}$, denote by $C(\Omega)$ the set of continuous functions from $\Omega$ to $\mathbb{R}$. We recall basic properties of the multivariate Bernstein polynomials described, e.g., in $[5,6]$.

Definition 1. (Multivariate Bernstein polynomials) Let $d \in \mathbb{N}^{n}$ and $f \in C\left([0,1]^{n}\right)$. The polynomials

$$
\begin{equation*}
B_{f, d}(x):=\sum_{k_{1}=0}^{d_{1}} \cdots \sum_{k_{n}=0}^{d_{n}} f\left(\frac{k_{1}}{d_{1}}, \ldots, \frac{k_{n}}{d_{n}}\right) \prod_{j=1}^{n}\left[\binom{d_{j}}{k_{j}} x_{j}^{k_{j}}\left(1-x_{j}\right)^{d_{j}-k_{j}}\right] \tag{44}
\end{equation*}
$$

are called the multivariate Bernstein polynomials of $f$.
Note that $\operatorname{deg}\left(B_{f, d}\right)=\sum_{j \in[n]} d_{j}$ and the binomial identity implies

$$
\begin{equation*}
\sup _{x \in[0,1]^{n}}\left|B_{f, d}(x)\right| \leq \sup _{x \in[0,1]^{n}}|f(x)| \tag{45}
\end{equation*}
$$

Lemma 6. (Error bound) If $f \in C\left([0,1]^{n}\right)$ is L-Lipschitz, namely $|f(x)-f(y)| \leq$ $L\|x-y\|_{2}$ on $[0,1]^{n}$, then for all $d \in \mathbb{N}^{n}$, the inequality

$$
\begin{equation*}
\left|B_{f, d}(x)-f(x)\right| \leq \frac{L}{2}\left(\sum_{j=1}^{n} \frac{1}{d_{j}}\right)^{\frac{1}{2}} \tag{46}
\end{equation*}
$$

holds for all $x \in[0,1]^{n}$.
Proof. Let $x \in[0,1]^{n}$ be fixed. To simplify the notation, we define $b_{j}:=\binom{d_{j}}{k_{j}} x_{j}^{k_{j}}(1-$ $\left.x_{j}\right)^{d_{j}-k_{j}}$, for $j \in[n]$, and $k=\left(\frac{k_{1}}{d_{1}}, \ldots, \frac{k_{n}}{d_{n}}\right)$. Then, we have:

$$
\begin{align*}
\left|B_{f, d}(x)-f(x)\right|^{2} & \leq\left(\sum^{2}|f(k)-f(x)| b_{1} \cdots b_{n}\right)^{2} \\
& \leq L^{2}\left(\sum_{n}\|k-x\|_{2} b_{1} \cdots b_{n}\right)^{2} \\
& \leq L^{2}\left(\sum\|k-x\|_{2}^{2} b_{1} \cdots b_{n}\right)\left(\sum b_{1} \cdots b_{n}\right) \\
& =L^{2} \sum^{2}\left(\sum_{r}\left(\frac{k_{r}}{d_{r}}-x_{r}\right)^{2}\right) b_{1} \cdots b_{n}  \tag{47}\\
& \left.=L^{2} \sum_{r}\left(\sum_{\left(\frac{k r}{}\right.}^{d_{r}}-x_{r}\right)^{2} b_{1} \cdots b_{n}\right) \\
& =L^{2} \sum_{r} \frac{x_{r}\left(1-x_{r}\right)}{d_{r}} \\
& \leq L^{2} \sum_{r} \frac{1}{4 d_{r}} .
\end{align*}
$$

For the first inequality, we have used the multinomial identity $1=\prod_{j}\left[x_{j}+\left(1-x_{j}\right)\right]^{d_{j}}=$ $\sum b_{1} \ldots b_{n}$ and the triangle inequality. For the second one, we have used the fact that $f$ is $L$-Lipschitz. For the third one, we use that for all $a, b \in \mathbb{R}^{n}$ and all $c \in \mathbb{R}_{+}^{n}$, one has $\left(\sum a_{k} b_{k} c_{k}\right)^{2} \leq\left(\sum a_{k}^{2} c_{k}\right)\left(\sum b_{k}^{2} c_{k}\right)$. The last equality comes from the identities $\sum_{k_{r}=0}^{d_{r}}\left(k_{r}-d_{r} x_{r}\right)^{2} b_{r}=d_{r} x_{r}\left(1-x_{r}\right)$ and $\prod_{j \neq r}\left(\sum_{k_{j}=0}^{d_{j}} b_{j}\right)=1$. The last inequality is obtained by noticing that we have $x_{r}\left(1-x_{r}\right) \leq 1 / 4$.

Let $e:=(1, \ldots, 1) \in \mathbb{R}^{n}$. As a consequence of Lemma 6 , we obtain the following result after a change of coordinates.

Lemma 7. If $f \in C\left([0,1]^{n}\right)$ is L-Lipschitz, namely $|f(x)-f(y)| \leq L\|x-y\|_{2}$ on $[-1,1]^{n}$, then for all $k \in \mathbb{N}^{\geq 1}$, the inequality

$$
\begin{equation*}
\left|B_{y \mapsto f(2 y-e), k e}\left(\frac{x+e}{2}\right)-f(x)\right| \leq L\left(\frac{n}{k}\right)^{\frac{1}{2}} \tag{48}
\end{equation*}
$$

holds for all $x \in[-1,1]^{n}$. Moreover, we have

$$
\begin{equation*}
\sup _{x \in[-1,1]^{n}}\left|B_{y \mapsto f(2 y-e), k e}\left(\frac{x+e}{2}\right)\right| \leq \sup _{x \in[-1,1]^{n}}|f(x)| . \tag{49}
\end{equation*}
$$

Proof. Define $g:[0,1]^{n} \rightarrow \mathbb{R}$ by $g(x):=f(2 x-e)$. Let us compute a Lipschitz constant of $g$. With $x, y \in[0,1]^{n}$, by the Lipschitz continuity of $f$, we have

$$
\begin{align*}
|g(x)-g(y)| & =|f(2 x-e)-f(2 y-e)| \\
& \leq L\|2 x-e-2 y+e\|_{2}  \tag{50}\\
& =2 L\|x-y\|_{2} .
\end{align*}
$$

Then $2 L$ is a Lipschitz constant of $g$. Let $k \in \mathbb{N}^{\geq 1}$. Using Lemma 6, we get that for all $x \in[0,1]^{n}$,

$$
\begin{equation*}
\left|B_{g, k e}(x)-g(x)\right| \leq \frac{2 L}{2}\left(\sum_{j=1}^{n} \frac{1}{k}\right)^{\frac{1}{2}}=L\left(\frac{n}{k}\right)^{\frac{1}{2}} \tag{51}
\end{equation*}
$$

Let $y \in[-1,1]^{n}$. Then $\frac{y+e}{2} \in[0,1]$ implies that

$$
\begin{equation*}
\left|B_{g, k e}\left(\frac{y+e}{2}\right)-f(y)\right|=\left|B_{g, k e}\left(\frac{y+e}{2}\right)-g\left(\frac{y+e}{2}\right)\right| \leq L\left(\frac{n}{k}\right)^{\frac{1}{2}} . \tag{52}
\end{equation*}
$$

yielding (48).
In addition, from (45),

$$
\begin{align*}
\sup _{y \in[-1,1]}\left|B_{g, k e}\left(\frac{y+e}{2}\right)\right| & =\sup _{x \in[0,1]^{n}}\left|B_{g, k e}(x)\right| \\
& \leq \sup _{x \in[0,1]^{n}}|g(x)|  \tag{53}\\
& =\sup _{y \in[-1,1]}\left|g\left(\frac{y+e}{2}\right)\right|=\sup _{y \in[-1,1]}|f(y)|,
\end{align*}
$$

which yields (49).
For each $h \in \mathbb{R}[x]$, let

$$
\begin{equation*}
\Theta(h):=\frac{\sup _{x \in \mathbb{S}^{n-1}} h(x)}{\inf _{x \in \mathbb{S}^{n-1}} h(x)} . \tag{54}
\end{equation*}
$$

For later use recall the following theorem.
Lemma 8. (Reznick [19, Theorem 3.12]) Suppose that $p \in \mathbb{R}[x]$ is a positive definite form of degree $2 d$, for some $d \in \mathbb{N}$. Then for all $k \in \mathbb{N}$ satisfying

$$
\begin{equation*}
k \geq \frac{2 n d(2 d-1)}{4 \log 2} \Theta(p)-\frac{n+2 d}{2} \tag{55}
\end{equation*}
$$

$\|x\|_{2}^{2 k} p$ is a homogeneous SOS polynomial of degree $2(k+d)$. More precisely, $\|x\|_{2}^{2 k} p$ is a sum of powers of linear forms.

### 3.4 The proof of Theorem 2

Recall that $[l]:=\{1, \ldots, l\}$ for $l \in \mathbb{N}^{\geq 1}$. Given real value functions $p, q$, we use the notation $\{p * q\}=\left\{x \in \mathbb{R}^{n}: p(x) * q(x)\right\}$, where $* \in\{=, \geq, \leq,>,<\}$. Given a real value function $p$ on $\Omega \subset \mathbb{R}^{n}$, note $\|p\|_{\Omega}:=\sup _{x \in \Omega}|p(x)|$. With $\Omega \subset \mathbb{R}^{n}$, denote by $\operatorname{int}(\Omega)$ the interior of $\Omega$.

Given $U, V \subseteq \mathbb{R}^{n}$ and $r \in \mathbb{R}$, note $U+V=\{u+v: u \in U, v \in V\}$ and $r U=\{r u: u \in U\}$. Given a function $f: U \rightarrow \mathbb{R}$ and $A \subset U \subset \mathbb{R}^{n}$ such that $A=-A$, $f$ is called even on $A$ if $f(-x)=f(x)$ for all $x \in A$. Denote by $\mathbb{S}^{n-1}$ the unit sphere of $\mathbb{R}^{n}$.

To begin the proof, let us fix $\varepsilon>0$. By assumption, $\operatorname{deg}(f)=2 d_{f}, \operatorname{deg}\left(g_{j}\right)=2 d_{g_{j}}$ for some $d, d_{g_{j}} \in \mathbb{N}$, for $j \in[m]$.

### 3.4.1 Construction of the positive weight functions

For $j \in[m]$, define

$$
\begin{equation*}
S_{j}:=\left\{x \in \mathbb{R}^{n}: g_{i}(x) \geq 0, i \in[j]\right\} . \tag{56}
\end{equation*}
$$

Obviously, we have $S_{m}=S$. Note $S_{0}:=\mathbb{R}^{n}$ and $f_{m}:=f$.
We will prove that there exist functions $\bar{\varphi}_{m}: \mathbb{R}^{n} \rightarrow \mathbb{R}$ such that the following conditions hold:

1. $\bar{\varphi}_{m}$ is positive, even and bounded from above by $C_{\bar{\varphi}_{m}}=\bar{r}_{m} \varepsilon^{-r_{m}}$ on $B(0, \sqrt{n}+m)$ for some positive constants $\bar{r}_{m}$ and $r_{m}$ independent of $\varepsilon$.
2. $\bar{\varphi}_{m}$ is Lipschitz with Lipschitz constant $L_{\bar{\varphi}_{m}}=\bar{t}_{j} \varepsilon^{-t_{m}}$ for some positive constants $\bar{t}_{m}$ and $t_{m}$ independent of $\varepsilon$.
3. $f_{m-1}:=f_{m}+\frac{\varepsilon}{2}-\bar{\varphi}_{m}^{2} g_{m}$ satisfies:
(a) $f_{m-1} \geq 0$ on $S_{m-1} \cap B(0, \sqrt{n}+m-1)$;
(b) $f_{m-1} \leq C_{f_{m-1}}$ on $B(0, \sqrt{n}+m)$, where $C_{f_{m-1}}=\bar{c}_{m-1} \varepsilon^{-c_{m-1}}$ for some positive constants $\bar{c}_{m-1}$ and $c_{m-1}$ independent of $\varepsilon$;
(c) $f_{m-1}$ is Lipschitz on $B(0, \sqrt{n}+m)$ with Lipschitz constant $L_{f_{m-1}}=$ $\bar{l}_{m-1} \varepsilon^{-l_{m-1}}$ for some positive constants $\bar{l}_{m-1}$ and $l_{m-1}$ independent of $\varepsilon$.

Let

$$
\begin{equation*}
M_{m}:=\inf _{x \in S_{m} \cap B(0, \sqrt{n}+m)} \frac{f(x)+\frac{\varepsilon}{2}}{g_{m}(x)} . \tag{57}
\end{equation*}
$$

The constant $M_{m}$ is a positive real number. Let $C_{g_{m}}=\left\|g_{m}\right\|_{B(0, \sqrt{n}+m)}$. We claim that $\frac{\varepsilon}{2 C g_{m}}<M_{m}<\infty$. Indeed, if $z$ is a feasible solution of (57), $z \in S$ yielding $f(z) \geq 0$ so that

$$
\begin{equation*}
\frac{f(z)+\frac{\varepsilon}{2}}{g_{m}(z)} \geq \frac{\varepsilon}{2 g_{m}(z)} \geq \frac{\varepsilon}{2 C_{g_{m}}} . \tag{58}
\end{equation*}
$$

From this, we have $M_{m}>\frac{\varepsilon}{2 C g_{m}}$. On the other hand, there exists $a \in \mathbb{R}^{n}$ such that $g_{j}(a)>0$ for $j \in[m]$ since $S$ has nonempty interior. For $j \in[m]$, since $g_{j}$ is homogeneous, $a=0$ yields $g_{j}(a)=0$. It implies that $a \neq 0$. With $\bar{a}=\frac{a}{\|a\|_{2}} \in$ $B(0,1) \subset B(0, \sqrt{n}+m)$, we obtain $g_{j}(\bar{a})>0$ for $j \in[m]$ since

$$
\begin{equation*}
g_{j}(\bar{a})=g_{j}\left(\frac{a}{\|a\|_{2}}\right)=\frac{g_{j}(a)}{\|a\|_{2}^{2 g_{g_{j}}}}>0, \forall j \in[m] . \tag{59}
\end{equation*}
$$

Thus, $\bar{a}$ is a feasible solution of (57) which yields

$$
\begin{equation*}
\frac{\varepsilon}{2 C_{g_{m}}} \leq M_{m} \leq \frac{f(\bar{a})+\frac{\varepsilon}{2}}{g_{m}(\bar{a})} \leq \frac{C_{f}+\frac{\varepsilon}{2}}{g_{m}(\bar{a})}<\infty, \tag{60}
\end{equation*}
$$

where $C_{f}:=\|f\|_{B(0, \sqrt{n}+m)}$.
Let $\psi_{m}: \mathbb{R}^{n} \rightarrow \mathbb{R}$ be the function defined by

$$
\psi_{m}(x):= \begin{cases}\max \left\{M_{m}, \frac{f(x)+\frac{\varepsilon}{2}}{g_{m}(x)}\right\} & \text { if } g_{m}(x)<0,  \tag{61}\\ M_{m} & \text { otherwise }\end{cases}
$$

The function $f+\frac{\varepsilon}{2}-\psi_{m} g_{m}$ is nonnegative on $S_{m-1} \cap B(0, \sqrt{n}+m)$. Namely, we claim that

$$
\begin{equation*}
f+\frac{\varepsilon}{2}-\psi_{m} g_{m} \geq 0 \text { on } S_{m-1} \cap B(0, \sqrt{n}+m) \tag{62}
\end{equation*}
$$

Let $y \in S_{m-1} \cap B(0, \sqrt{n}+m)$. If $g_{m}(y)<0$, then

$$
\begin{align*}
f(y)+\frac{\varepsilon}{2}-\psi_{m}(y) g_{m}(y) & =f(y)+\frac{\varepsilon}{2}-g_{m}(y) \max \left\{M_{m}, \frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}\right\} \\
& \geq f(y)+\frac{\varepsilon}{2}-g_{m}(y) \frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}=0 . \tag{63}
\end{align*}
$$

Otherwise, $g_{m}(y) \geq 0$ gives

$$
\begin{align*}
f(y)+\frac{\varepsilon}{2}-\psi_{m}(y) g_{m}(y) & =f(y)+\frac{\varepsilon}{2}-g_{m}(y) M_{m} \\
& \begin{cases}\geq f(y)+\frac{\varepsilon}{2}-g_{m}(y) \frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}=0 & \text { if } g_{m}(y)>0, \\
=f(y)+\frac{\varepsilon}{2} \geq 0 & \text { if } g_{m}(y)=0\end{cases} \tag{64}
\end{align*}
$$

since $y \in S$ is a feasible solution of (57).
The function $\psi_{m}$ is positive, even on $B(0, \sqrt{n}+m)$ and continuous on $S_{m-1} \cap B(0, \sqrt{n}+m)$. It is easy to see that $\psi_{m}$ is bounded from below by $M_{m}$ and continuous on $B(0, \sqrt{n}+m) \backslash\left\{g_{m}=0\right\}$ since the max function $\left(t_{1}, t_{2}\right) \mapsto \max \left\{t_{1}, t_{2}\right\}$ is continuous.

We claim that $\psi_{m}$ is continuous on $S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{g_{m}=0\right\}$. Indeed, let us consider a sequence $\left(y_{l}\right)_{l} \subset S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{g_{m}<0\right\}$ such that $y_{l} \rightarrow$ $\bar{y} \in S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{g_{m}=0\right\}$. Then $g_{m}\left(y_{l}\right) \rightarrow 0^{-}$and $f\left(y_{l}\right) \rightarrow f(\bar{y}) \geq 0$ (since $\bar{y} \in S$ ) yielding that $\frac{f\left(y_{l}\right)+\frac{\varepsilon}{2}}{g_{m}\left(y_{l}\right)} \rightarrow-\infty$. It implies that $\max \left\{M_{m}, \frac{f\left(y_{l}\right)+\frac{\varepsilon}{2}}{g_{m}\left(y_{l}\right)}\right\} \rightarrow M_{m}$. Thus, $\psi_{m}=M_{m}$ on a sufficiently small neighborhood of any point in $S_{m-1} \cap B(0, \sqrt{n}+$ $m) \cap\left\{g_{m}=0\right\}$. On the other hand, $\psi_{m}$ is even, i.e., $\psi_{m}(x)=\psi_{m}(-x)$ due to the fact that $f, g_{1}, \ldots, g_{m}$ are even and $B(0, \sqrt{n}+m)=-B(0, \sqrt{n}+m)$.

The upper bound of $\psi_{m}$ depends on $\varepsilon$. It follows from (60) that $\psi_{m}=M_{m}$ on $B(0, \sqrt{n}+m) \cap\left\{g_{m} \geq 0\right\}$ and so is bounded from above by $\frac{f(\bar{a})+\frac{\varepsilon}{2}}{g_{m}(\bar{a})}$.

Let us compute an upper bound of $\psi_{m}$ on $S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{g_{m}<0\right\}$. Let $y \in S_{m-1} \cap B(0, \sqrt{n}+m)$ be such that $g_{m}(y)<0$ and $\frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}>M_{m}$. Then $\psi_{m}(y)=$ $\frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}$. By using the Lojasiewicz inequality (see Lemma 2), there exist $C_{m}>0$ and $\alpha_{m}>0$ depending on $g_{1}, \ldots, g_{m}$ such that for all $x \in S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{g_{m}<0\right\}$,

$$
\begin{equation*}
\operatorname{dist}(x, S)^{\alpha_{m}} \leq-C_{m} \min \left\{g_{1}(x), \ldots, g_{m}(x), 0\right\}=-C_{m} g_{m}(x) \tag{65}
\end{equation*}
$$

Let $\delta_{m}=\frac{1}{C_{m}}\left(\frac{\varepsilon}{2 L_{f}}\right)^{\alpha_{m}}$, where $L_{f}$ is a Lipschitz constant of $f$ on $B(0, \sqrt{n}+m)$. Consider the following two cases:

- Case 1: $g_{m}(y) \leq-\delta_{m}<0$. Then

$$
\begin{equation*}
\psi_{m}(y)=\frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}=\frac{-f(y)-\frac{\varepsilon}{2}}{-g_{m}(y)} \leq \frac{C_{f}}{-g_{m}(y)} \leq \frac{C_{f}}{\delta_{m}} \leq C_{m} C_{f}\left(\frac{2 L_{f}}{\varepsilon}\right)^{\alpha_{m}} \tag{66}
\end{equation*}
$$

- Case 2: $-\delta_{m} \leq g_{m}(y)<0$. Let $z \in S$ such that $\operatorname{dist}(y, S)=\|y-z\|_{2}$. Then (65) turns to $-f(y) \leq \frac{\varepsilon}{2}$ according to

\begin{align*}
-f(y) & \leq-f(z)+L_{f}\|y-z\|_{2} \leq L_{f} \operatorname{dist}(y, S) \\
& \leq L_{f}\left(-C_{m} g_{m}(y)\right)^{\frac{1}{\alpha_{m}}} \leq L_{f}\left(C_{m} \delta_{m}\right)^{\frac{1}{\alpha_{m}}}=\frac{\varepsilon}{2} . \tag{67}
\end{align*}
$$

From this, we obtain

M_{m}<\frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}=\frac{-f(y)-\frac{\varepsilon}{2}}{-g_{m}(y)} \leq \frac{\frac{\varepsilon}{2}-\frac{\varepsilon}{2}}{-g_{m}(y)}=0<M_{m} . \tag{68}
\end{equation*}
$$

The contradiction indicates that this case does not occur.

Thus, the bound is given as follows

\sup _{x \in S_{m-1} \cap B(0, \sqrt{n}+m)} \psi_{m}(x) \leq \max \left\{\frac{f(\bar{a})+\frac{\varepsilon}{2}}{g_{m}(\bar{a})}, C_{m} C_{f}\left(\frac{2 L_{f}}{\varepsilon}\right)^{\alpha_{m}}\right\}=: C_{\psi_{m}} \tag{69}
\end{equation*}
$$

Moreover, we obtain the inclusion

S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\} \subset\left\{g_{m} \leq-\delta_{m}\right\}, \tag{70}
\end{equation*}
$$

where $\xi_{m}(x)=\frac{f(x)+\frac{\varepsilon}{2}}{g_{m}(x)}$. Let $\varphi_{m}$ be the square root of $\psi_{m}$, i.e., $\varphi_{m}(x):=\sqrt{\psi_{m}(x)}$. Then $\varphi_{m}$ is well-defined on $B(0, \sqrt{n}+m)$ since $\psi_{m}$ is positive. Moreover, $\varphi_{m}$ is finitely bounded from above on $S_{m-1} \cap B(0, \sqrt{n}+m)$ by $C_{\varphi_{m}}:=\sqrt{C_{\psi_{m}}}$ and $\varphi_{m}$ is continuous on $S_{m-1} \cap B(0, \sqrt{n}+m)$ since $\xi_{m}$ is continuous on $S_{m-1} \cap B(0, \sqrt{n}+m)$.

The function $\varphi_{m}$ is Lipschitz continuous on $S_{m-1} \cap B(0, \sqrt{n}+m-1)$. Keep in mind that $\psi_{m}$ is defined by the constant function $M_{m}$ and the function $\xi_{m}$. Since $\varphi_{m}$ takes the constant value $\sqrt{M_{m}}$ on $B(0, \sqrt{n}+m) \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}\right)$, $\varphi_{m}$ is Lipschitz continuous on $B(0, \sqrt{n}+m) \backslash\left(\left\{\varphi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}\right)$ with zero Lipschitz constant.

On the other hand, $\varphi_{m}=\sqrt{\xi_{m}}$ on $B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}$. As a consequence of (70), we have

\begin{align*}
& S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\} \\
= & S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\} . \tag{71}
\end{align*}
$$

It implies that

\varphi_{m}(x)= \begin{cases}\sqrt{\xi_{m}(x)} & \text { if } x \in S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}  \tag{72}\\ \sqrt{M_{m}} & \text { if } x \in\left(S_{m-1} \cap B(0, \sqrt{n}+m)\right) \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}\right)\end{cases}
$$

The second equality is due to the fact that $\varphi_{m}=\sqrt{M_{m}}$ on $\left(S_{m-1} \cap B(0, \sqrt{n}+\right.$ $m)) \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}\right)$ and

\begin{align*}
& \left(S_{m-1} \cap B(0, \sqrt{n}+m)\right) \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}\right) \\
= & \left(S_{m-1} \cap B(0, \sqrt{n}+m)\right) \backslash\left[S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq 0\right\}\right] \\
= & \left(S_{m-1} \cap B(0, \sqrt{n}+m)\right) \backslash\left[S_{m-1} \cap B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}\right] \\
= & \left(S_{m-1} \cap B(0, \sqrt{n}+m)\right) \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}\right) . \tag{73}
\end{align*}
$$

Let $L_{g_{m}}$ be a Lipschitz constant of $g_{m}$ on $B(0, \sqrt{n}+m)$. Set

\begin{equation*}
w_{m}:=\min \left\{1, \frac{\delta_{m}}{2 L_{g_{m}}}, \frac{\varepsilon \delta_{m}^{2}}{8 C_{g_{m}}\left[L_{f} C_{g_{m}}+\left(C_{f}+\frac{\varepsilon}{2}\right) L_{g_{m}}\right]}\right\} . \tag{74}
\end{equation*}
$$

and

$$
\begin{equation*}
W_{m}:=\left(B(0, \sqrt{n}+m-1) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}\right)+w_{m} B(0,1) . \tag{75}
\end{equation*}
$$

Then $B(0, \sqrt{n}+m-1) \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\} \subset W_{m}$. Next, we prove that

$$
\begin{equation*}
W_{m} \subset B(0, \sqrt{n}+m) \cap\left\{\xi_{m} \geq \frac{M_{m}}{2}\right\} \cap\left\{g_{m} \leq-\frac{\delta_{m}}{2}\right\} \tag{76}
\end{equation*}
$$

Let $y \in W_{m}$. Then $y=z+w_{m} u$ for some $z \in S_{m-1} \cap B(0, \sqrt{n}+m-1) \cap\left\{\xi_{m} \geq\right.$ $\left.M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}$ and for some $u \in B(0,1)$. Combining $\|z\|_{2} \leq \sqrt{n}+m-1$, $0<w_{m}<1$ and $\|u\|_{2} \leq 1$, one has $\|y\|_{2} \leq\|z\|_{2}+w_{m}\|u\|_{2} \leq \sqrt{n}+m$, yielding $y \in B(0, \sqrt{n}+m)$. Since $g_{m}(z) \leq-\delta_{m}$, we have

g_{m}(y) \leq g_{m}(z)+L_{g_{m}}\|y-z\|_{2} \leq-\delta_{m}+L_{g_{m}} w_{m}\|u\|_{2} \leq-\delta_{m}+L_{g_{m}} \frac{\delta_{m}}{2 L_{g_{m}}} \leq-\frac{\delta_{m}}{2} \tag{77}
\end{equation*}
$$

Thus $y \in\left\{g_{m} \leq-\frac{\delta_{m}}{2}\right\}$. This in turn implies

&\left|\xi_{m}(y)-\xi_{m}(z)\right| \\
&=\left|\frac{f(y)+\frac{\varepsilon}{2}}{g_{m}(y)}-\frac{f(z)+\frac{\varepsilon}{2}}{g_{m}(z)}\right| \\
&=\frac{\left|\left(f(y)+\frac{\varepsilon}{2}\right) g_{m}(z)-\left(f(z)+\frac{\varepsilon}{2}\right) g_{m}(y)\right|}{\left|g_{m}(y)\right|\left|g_{m}(z)\right|}  \tag{78}\\
& \leq \frac{2}{\delta^{2}}\left|\left(f(y)+\frac{\varepsilon}{2}-f(z)-\frac{\varepsilon}{2}\right) g_{m}(z)+\left(f(z)+\frac{\varepsilon}{2}\right)\left(g_{m}(z)-g_{m}(y)\right)\right| \\
& \leq \frac{2_{n}}{\delta_{n}^{2}}\left[|f(y)-f(z)|\left|g_{m}(z)\right|+\left(|f(z)|+\frac{\varepsilon}{2}\right)\left|g_{m}(z)-g_{m}(y)\right|\right] \\
& \leq \frac{\sum_{2}}{\delta^{2}}\left[L_{f}\|y-z\|_{2} C_{g_{m}}+\left(C_{f}+\frac{\varepsilon}{2}\right) L_{g_{m}}\|z-y\|_{2}\right] \\
& \leq \frac{\sum_{2}}{\delta_{m}^{2}}\left[L_{f} C_{g_{m}}+\left(C_{f}+\frac{\varepsilon}{2}\right) L_{g_{m}}\right] w_{m}\|u\|_{2} \leq \frac{\varepsilon}{4 C_{g_{m}}} \leq \frac{M_{m}}{2} .
\end{align*}
$$

Since $\xi_{m}(z) \geq M_{m}$, we obtain $\xi_{m}(y) \geq \xi_{m}(z)-\left|\xi_{m}(y)-\xi_{m}(z)\right| \geq M_{m}-\frac{M_{m}}{2}=\frac{M_{m}}{2}$, yielding $y \in\left\{\xi_{m} \geq \frac{M_{m}}{2}\right\}$, which concludes the proof of (76) and ensures that $\sqrt{\xi_{m}}$ is well-defined on $W_{m}$.

Let us prove that $\sqrt{\xi_{m}}$ is Lipschitz on $W_{m}$. Let $y, z \in W_{m}$ such that $y \neq z$. Then

& =\frac{\left.\frac{\left|\sqrt{\xi_{m}(y)}-\sqrt{\xi_{m}(z)}\right|}{\|y-z\|_{2}}\right)}{\|y-z\|_{m}\left(\sqrt{(y)-\xi_{m}(z) \mid}\right.}
\end{aligned}
$$

$$
\begin{align*}
& \leq \frac{\left|\left(f(y)+\frac{\varepsilon}{2}\right) g_{m}(z)-\left(f_{m}(z)+\frac{\varepsilon}{2}\right) g_{m}(y)\right|}{2 g_{m}(y) g_{m}(z) \sqrt{\frac{\varepsilon}{\varepsilon} C_{g_{m}}}\|y-z\|_{2}} \\
& \leq \frac{2\left|\left(f(y)+\frac{\varepsilon}{2}\right) g_{m}(z)-\left(f_{m}(z)+\frac{\varepsilon}{2}\right) g_{m}(y)\right|}{\delta_{m}^{2} \sqrt{\frac{\varepsilon}{4 C_{g}}}\|y-z\|_{2}}  \tag{79}\\
& =\frac{2\left|\left(f(y)+\frac{\varepsilon}{2}-f(z)-\frac{g_{2}}{2}\right) g_{m}(z)+\left(f(z)+\frac{\varepsilon}{2}\right)\left(g_{m}(z)-g_{m}(y)\right)\right|}{\delta_{m}^{2} \sqrt{\frac{\varepsilon}{\epsilon C g_{m}}}\|y-z\|_{2}} \\
& \leq \frac{2\left[\left|f(y)-f(z)\left\|g_{m}(z)\left|+\left(|f(z)|+\frac{\varepsilon}{2}\right)\right| g_{m}(z)-g_{m}(y)\right\|\right.\right.}{\delta_{m}^{2} \sqrt{\frac{\varepsilon}{4 C_{g}}}\|y-z\|_{2}} \\
& \leq \frac{2\left[L_{f}\|y-z\|_{2} C_{g_{m}}+\left(C_{f}+\frac{2}{\varepsilon}\right) L_{g_{m}}\|z-y\|_{2}\right]}{\delta_{m}^{2} \sqrt{4 C_{g_{m}}}\|y-z\|_{2}} \\
& \leq \frac{2\left[L_{f} C_{g_{m}}+\left(C_{f}+\frac{\varepsilon_{2}}{g_{2}}\right) L_{g_{m}}\right]}{\delta_{m}^{2} \sqrt{\overline{4} C_{g_{m}}}}=: L_{\sqrt{\xi_{m}}},
\end{align*}
$$

Thus, $L_{\sqrt{\xi_{m}}}$ is a Lipschitz constant of $\sqrt{\xi_{m}}$ on $W_{m}$.
Set $K:=S_{m-1} \cap B(0, \sqrt{n}+m-1), K_{1}:=K \cap\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}$ and $K_{2}:=K \backslash\left(\left\{\xi_{m} \geq M_{m}\right\} \cap\left\{g_{m} \leq-\delta_{m}\right\}\right)$. Note that $K=K_{1} \cup K_{2}$ and $K_{1} \cap K_{2}=\emptyset$. From (72), $\varphi_{m}=\sqrt{\xi_{m}}$ on $K_{1}$ and $\varphi_{m}=\sqrt{M_{m}}$ on $K_{2}$.

To conclude that $\varphi_{m}$ is Lipschitz on $K$ according to Lemma 4 (see Figure 1), it is sufficient to prove that $\varphi_{m}$ is locally Lipschitz on $K$.

Explicitly, we will show that for all $z \in K, \varphi_{m}$ is Lipschitz on $B\left(z, \frac{w_{m}}{2}\right) \cap K$ with Lipschitz constant $L_{\sqrt{\xi_{m}}}$. Let $z \in K$. Let $u, v \in B\left(z, \frac{w_{m}}{2}\right) \cap K$ and consider the following cases:

- Case 1: $u, v \in K_{1}$. Then $u, v \in W_{m}$ by definition of $W_{m}$. Moreover, $\varphi_{m}(u)=$ $\sqrt{\xi_{m}(u)}$ and $\varphi_{m}(v)=\sqrt{\xi_{m}(v)}$. In this case, by the Lipschitz continuity of $\sqrt{\xi_{m}}$ on $W_{m}$,

\left|\varphi_{m}(u)-\varphi_{m}(v)\right|=\left|\sqrt{\xi_{m}(u)}-\sqrt{\xi_{m}(v)}\right| \leq L_{\sqrt{\xi_{m}}}\|u-v\|_{2} . \tag{80}
\end{equation*}
$$

- Case 2: $u, v \in K_{2}$. In this case, $\varphi_{m}(u)=\varphi_{m}(v)=\sqrt{M_{m}}$, so that

\left|\varphi_{m}(u)-\varphi_{m}(v)\right|=0 \leq L_{\sqrt{\xi_{m}}}\|u-v\|_{2} . \tag{81}
\end{equation*}
$$

- Case 3: $u \in K_{1}$ and $v \in K_{2}$. We claim that $B\left(z, \frac{w_{m}}{2}\right) \subset W_{m}$. Let $q \in B\left(z, \frac{w_{m}}{2}\right)$. Then $\|q-u\|_{2} \leq\|q-z\|_{2}+\|z-u\|_{2} \leq w_{m}$ yielding $q \in u+w_{m} B(0,1) \subset K_{1}+$ $w_{m} B(0,1) \subset W_{m}$. Then $u, v \in B\left(z, \frac{\overline{w_{m}}}{2}\right) \subset W_{m}$. Moreover, $\varphi_{m}(u)=\sqrt{\xi_{m}(u)}$

and $\varphi_{m}(v)=\sqrt{M_{m}}$. According to the continuity of $\xi_{m}$ on $B\left(z, \frac{w_{m}}{2}\right) \subset W_{m}$ and the convexity of $B\left(z, \frac{w_{m}}{2}\right)$, there exists $y \in B\left(z, \frac{w_{m}}{2}\right) \cap\left\{\xi_{m}=M_{m}^{2}\right\} \cap\{t u+(1-$ $t) v: t \in[0,1]\}$. Then with $y=\lambda u+(1-\lambda) v$ for some $\lambda \in[0,1]$, we have

\left|\varphi_{m}(u)-\varphi_{m}(v)\right| & \leq\left|\varphi_{m}(u)-\varphi_{m}(y)\right|+\left|\varphi_{m}(y)-\varphi_{m}(v)\right| \\
& \leq\left|\sqrt{\xi_{m}(u)}-\sqrt{\xi_{m}(y)}\right|+\left|\sqrt{M_{m}}-\sqrt{M_{m}}\right| \\
& \leq L_{\sqrt{\xi_{m}}}\|u-y\|_{2}  \tag{82}\\
& \leq L_{\sqrt{\xi_{m}}}\|u-\lambda u-(1-\lambda) v\|_{2} \\
& \leq L_{\sqrt{\xi_{m}}}(1-\lambda)\|u-v\|_{2} \leq L_{\sqrt{\xi_{m}}}\|u-v\|_{2} .
\end{align*}
$$

From the proof of Lemma 4, the Lipschitz constant of $\varphi_{m}$ on $K$ is given by

$$
\begin{equation*}
L_{\bar{\varphi}_{m}}:=\max \left\{\frac{4 C_{\varphi_{m}}}{w_{m}}, L_{\sqrt{\xi_{m}}}\right\} \tag{83}
\end{equation*}
$$

Here we have covered $K$ by a finite sequence of balls with radii $\frac{w_{m}}{2}$ and centers lying on $K$.

The function $\varphi_{m}$ has a Lipschitz continuous extension $\bar{\varphi}_{m}$. Let $\bar{\varphi}_{m}$ : $\mathbb{R}^{n} \rightarrow \mathbb{R}$ be the function defined by

$$
\begin{equation*}
\bar{\varphi}_{m}(x):=\inf _{y}\left\{\varphi_{m}(y)+L_{\bar{\varphi}_{m}}\|x-y\|_{2}: y \in S_{m-1} \cap B(0, \sqrt{n}+m-1)\right\} \tag{84}
\end{equation*}
$$

By Kirszbraun's theorem (stated in Lemma 5), $\bar{\varphi}_{m}$ is Lipschitz continuous with Lipschitz constant $L_{\bar{\varphi}_{m}}$ and $\bar{\varphi}_{m}=\varphi_{m}$ on $S_{m-1} \cap B(0, \sqrt{n}+m-1)$.

The function $\bar{\varphi}_{m}$ is even, positive and has a finite upper bound on $B(0, \sqrt{n}+m)$ depending on $\varepsilon$. Let us prove that $\bar{\varphi}_{m}$ is even. Consider

$$
\begin{equation*}
\bar{\varphi}_{m}(-x)=\inf _{y}\left\{\varphi_{m}(y)+L_{\bar{\varphi}_{m}}\|-x-y\|_{2}: y \in S_{m-1} \cap B(0, \sqrt{n}+m-1)\right\} . \tag{85}
\end{equation*}
$$

Let $y$ be any feasible solution of (85). Since $g_{1}, \ldots, g_{m-1}$ are even, $S_{m-1} \cap B(0, \sqrt{n}+m)$ is symmetric, i.e., $S_{m-1} \cap B(0, \sqrt{n}+m)=-S_{m-1} \cap B(0, \sqrt{n}+m)$, it turns out that $-y$ is a feasible solution of (85). Thus,

$$
\begin{align*}
\bar{\varphi}_{m}(-x) & =\inf _{-y}\left\{\varphi_{m}(-y)+L_{\bar{\varphi}_{m}}\|-x+y\|_{2}:-y \in S_{m-1} \cap B(0, \sqrt{n}+m-1)\right\} \\
& =\inf _{y}\left\{\varphi_{m}(y)+L_{\bar{\varphi}_{m}}\|y-x\|_{2}: y \in S_{m-1} \cap B(0, \sqrt{n}+m-1)\right\}=\bar{\varphi}_{m}(x), \tag{86}
\end{align*}
$$

where the latter inequality is due to the fact that $\varphi_{m}$ is even (since $\xi_{m}, g_{m}$ are even). From this, $\bar{\varphi}_{m}$ is even. It is not hard to show that $\bar{\varphi}_{m} \geq \sqrt{M_{m}}$ since $\varphi_{m} \geq \sqrt{M_{m}}$.

Let us estimate the upper bound of $\bar{\varphi}_{m}$ on $B(0, \sqrt{n}+m)$. Let $x \in B(0, \sqrt{n}+m)$ and $y \in S_{m-1} \cap B(0, \sqrt{n}+m-1)$. From (84), we get

\bar{\varphi}_{m}(x) \leq \varphi_{m}(y)+L_{\bar{\varphi}_{m}}\|x-y\|_{2} \leq C_{\varphi_{m}}+(2(\sqrt{n}+m)-1) L_{\bar{\varphi}_{m}}=: C_{\bar{\varphi}_{m}} \tag{87}
\end{equation*}
$$

Thus,

\sup _{x \in B(0, \sqrt{n}+m)} \bar{\varphi}_{m}(x) \leq C_{\bar{\varphi}_{m}} . \tag{88}
\end{equation*}
$$

Set $f_{m-1}:=f+\frac{\varepsilon}{2}-\bar{\varphi}_{m}^{2} g_{m}$.
From (62) and since $\bar{\varphi}_{m}=\varphi_{m}=\sqrt{\psi_{m}}$ on $S_{m-1} \cap B(0, \sqrt{n}+m-1), f_{m-1} \geq 0$ on $S_{m-1} \cap B(0, \sqrt{n}+m-1)$. Since $\bar{\varphi}_{m}$ is Lipschitz continuous, $f_{m-1}$ is Lipschitz continuous on $B(0, \sqrt{n}+m)$.

A bound and a Lipschitz constant of $f_{m-1}$ on $B(0, \sqrt{n}+m)$ both depend on $\varepsilon$. Let us compute an upper bound of $\left|f_{m-1}\right|$ on $B(0, \sqrt{n}+m)$. Let $y \in B(0, \sqrt{n}+$ $m$ ). Then

\left|f_{m-1}(y)\right| \leq|f(y)|+\frac{\varepsilon}{2}+\bar{\varphi}_{m}(y)^{2}\left|g_{m}(y)\right| \leq C_{f}+\frac{\varepsilon}{2}+C_{g_{m}} C_{\bar{\varphi}_{m}}^{2}=: C_{f_{m-1}} . \tag{89}
\end{equation*}
$$

Thus,

$$
\begin{equation*}
\left\|f_{m-1}\right\|_{B(0, \sqrt{n}+m)} \leq C_{f_{m-1}} \tag{90}
\end{equation*}
$$

We now estimate the Lipschitz constant of $f_{m-1}$ on $B(0, \sqrt{n}+m)$. Let $y, z \in$ $B(0, \sqrt{n}+m)$ such that $y \neq z$. Then

\begin{align*}
& \frac{\left|f_{m-1}(y)-f_{m-1}(z)\right|}{\|y-z\|_{2}} \\
& \leq \frac{|f(y)-f(z)|+\left|\bar{\varphi}_{m}(y)^{2} g_{m}(y)-\bar{\varphi}_{m}(z)^{2} g_{m}(z)\right|}{\|y-z\|_{2}} \\
& \leq \quad L_{f}+\frac{\left|\bar{\varphi}_{m}(y)^{2} g_{m}(y)-\bar{\varphi}_{m}(z)^{2} g_{m}(y)\right|}{\|y-z\|_{2}} \\
& +\frac{\left|\bar{\varphi}_{m}(z)^{2} g_{m}(y)-\bar{\varphi}_{m}(z)^{2} g_{m}(z)\right|}{\|y-z\|_{2}}  \tag{91}\\
& =\quad L_{f}+\frac{\left|g_{m}(y)\left\|\bar{\varphi}_{m}(y)+\bar{\varphi}_{m}(z)\right\| \bar{\varphi}_{m}(y)-\bar{\varphi}_{m}(z)\right|+\bar{\varphi}_{m}(z)^{2}\left|g_{m}(y)-g_{m}(z)\right|}{\|y-z\|_{2}} \\
& \leq \quad L_{f}+\frac{2 C_{g_{m}} C_{\bar{\varphi}_{m}} L_{\bar{\varphi}_{m}}\|y-z\|_{2}+C_{\varphi_{m}}^{2} L_{g_{m}}\|y-z\|_{2}}{\|y-z\|_{2}} \\
& =L_{f}+2 C_{g_{m}} L_{\bar{\varphi}_{m}} C_{\bar{\varphi}_{m}}+L_{g_{m}} C_{\bar{\varphi}_{m}}^{2}=: L_{f_{m-1}} \text {. }
\end{align*}
$$

Then, $L_{f_{m-1}}$ is a Lipschitz constant of $f_{m-1}$ on $B(0, \sqrt{n}+m)$.
Notice that $C_{\bar{\varphi}_{m}}, L_{\bar{\varphi}_{m}}, C_{f_{m-1}}, L_{f_{m-1}}$ are obtained by composing finitely many times the following operators: " + ", "-", " $\times ", " \div ", "|\cdot| ", "\left(x_{1}, x_{2}\right) \mapsto \max \left\{x_{1}, x_{2}\right\} "$, $"\left(x_{1}, x_{2}\right) \mapsto \min \left\{x_{1}, x_{2}\right\} ", "(\cdot)^{\alpha_{m}} "$ and " $\sqrt{\cdot} "$, where all arguments possibly depend on $\varepsilon$. Without loss of generality we can assume $C_{\bar{\varphi}_{m}}=\bar{r}_{m} \varepsilon^{-r_{m}}, L_{\bar{\varphi}_{m}}=\bar{t}_{m} \varepsilon^{-t_{m}}$, $C_{f_{m-1}}=\bar{c}_{m-1} \varepsilon^{-c_{m-1}}, L_{f_{m-1}}=\bar{l}_{m-1} \varepsilon^{-l_{m-1}}$ for some $\bar{r}_{m}, r_{m}, \bar{t}_{m}, t_{m}, \bar{c}_{m-1}, c_{m-1}$, $\bar{l}_{m-1}, l_{m-1}$ large enough and independent of $\varepsilon$.

Backward induction. Repeating the above process (after replacing $f_{j}$ by $f_{j-1}$ ) several times, we obtain functions $\bar{\varphi}_{j}: \mathbb{R}^{n} \rightarrow \mathbb{R}, j=m, m-1, \ldots, 1$, such that,

1. $\bar{\varphi}_{j}$ is positive, even and bounded from above by $C_{\bar{\varphi}_{j}}=\bar{r}_{j} \varepsilon^{-r_{j}}$ on $B(0, \sqrt{n}+j)$ for some positive constants $\bar{r}_{j}$ and $r_{j}$ independent of $\varepsilon$.
2. $\bar{\varphi}_{j}$ is Lipschitz with Lipschitz constant $L_{\bar{\varphi}_{j}}=\bar{t}_{j} \varepsilon^{-t_{j}}$ for some positive constants $\bar{t}_{j}$ and $t_{j}$ independent of $\varepsilon$.
3. $f_{j-1}:=f_{j}+\frac{\varepsilon}{2^{m-j+1}}-\bar{\varphi}_{j}^{2} g_{j}$ satisfies:
(a) $f_{j-1} \geq 0$ on $S_{j-1} \cap B(0, \sqrt{n}+j-1)$;
(b) $f_{j-1} \leq C_{f_{j-1}}$ on $B(0, \sqrt{n}+j)$, where $C_{f_{j-1}}=\bar{c}_{j-1} \varepsilon^{-c_{j-1}}$ for some positive constants $\bar{c}_{j-1}$ and $c_{j-1}$ independent of $\varepsilon$;
(c) $f_{j-1}$ is Lipschitz on $B(0, \sqrt{n}+j)$ with Lipschitz constant $L_{f_{j-1}}=\bar{l}_{j-1} \varepsilon^{-l_{j-1}}$ for some positive constants $\bar{l}_{j-1}$ and $l_{j-1}$ independent of $\varepsilon$.

Then

$$
\begin{align*}
f_{0} & =f_{1}+\frac{\varepsilon}{2^{m}}-\bar{\varphi}_{1}^{2} g_{1} \\
& =\left(f_{2}+\frac{\varepsilon}{2^{m-1}}-\bar{\varphi}_{2}^{2} g_{2}\right)+\frac{\varepsilon}{2^{m}}-\bar{\varphi}_{1}^{2} g_{1} \\
& =f_{2}+\left(\frac{\varepsilon}{2^{m-1}}+\frac{\varepsilon}{2^{m}}\right)-\bar{\varphi}_{2}^{2} g_{2}-\bar{\varphi}_{1}^{2} g_{1} \\
& =\cdots=f_{m}+\varepsilon \sum_{i=1}^{m} \frac{1}{2^{i}}-\sum_{i=1}^{m} \bar{\varphi}_{i}^{2} g_{i}  \tag{92}\\
& =f+\frac{\varepsilon}{2} \frac{1-\frac{1}{2^{m}}}{1-\frac{1}{2}}-\sum_{i=1}^{m} \bar{\varphi}_{i}^{2} g_{i} \\
& =f+\varepsilon\left(1-\frac{1}{2^{m}}\right)-\sum_{i=1}^{m} \bar{\varphi}_{i}^{2} g_{i} .
\end{align*}
$$

From this and since $f_{0} \geq 0$ on $S_{0} \cap B(0, \sqrt{n})=B(0, \sqrt{n}) \supset[-1,1]^{n}$, we obtain

\begin{equation*}
f+\varepsilon-\sum_{i=1}^{m} \bar{\varphi}_{i}^{2} g_{i} \geq \frac{\varepsilon}{2^{m}} \text { on }[-1,1]^{n} . \tag{93}
\end{equation*}
$$

### 3.4.2 Polynomial approximations for the weight functions

Approximating with Bernstein polynomials. For each $i \in[m]$, we now approximate $\bar{\varphi}_{i}$ on $[-1,1]^{n}$ with the following Bernstein polynomials:

$$
\begin{equation*}
B_{i}^{(d)}(x)=B_{y \mapsto \bar{\varphi}_{i}(2 y-e), d e}\left(\frac{x+e}{2}\right), \quad d \in \mathbb{N}, \tag{94}
\end{equation*}
$$

with $e=(1, \ldots, 1) \in \mathbb{R}^{n}$. By using Lemma 7 , for all $x \in[-1,1]^{n}$, for $i \in[m]$,

$$
\begin{equation*}
\left|B_{i}^{(d)}(x)-\bar{\varphi}_{i}(x)\right| \leq L_{\bar{\varphi}_{i}}\left(\frac{n}{d}\right)^{\frac{1}{2}}, \quad d \in \mathbb{N}, \tag{95}
\end{equation*}
$$

and the following inequality holds for all $x \in[-1,1]^{n}$, for $i \in[m]$ :

$$
\begin{equation*}
\left|B_{i}^{(d)}(x)\right| \leq \sup _{x \in[-1,1]^{n}}\left|\bar{\varphi}_{i}(x)\right| \leq C_{\bar{\varphi}_{i}} . \tag{96}
\end{equation*}
$$

For $i \in[m]$, let

$$
\begin{equation*}
d_{i}:=2 u_{i} \quad \text { with } \quad u_{i}=\left\lceil\frac{2 C_{g_{i}}^{2} C_{\bar{\varphi}_{i}}^{2} n L_{\bar{\varphi}_{i}}^{2}(m+1)^{2} 2^{2 m}}{\varepsilon^{2}}\right\rceil, \tag{97}
\end{equation*}
$$

where $C_{g_{i}}:=\left\|g_{i}\right\|_{B(0, \sqrt{n}+i)}$, for $i \in[m]$. Then for all $x \in[-1,1]^{n}$,

$$
\begin{align*}
\left|B_{i}^{\left(d_{i}\right)}(x)-\bar{\varphi}_{i}(x)\right| & \leq L_{\bar{\varphi}_{i}}\left(\frac{n}{d_{i}}\right)^{\frac{1}{2}} \\
& \leq L_{\bar{\varphi}_{i}}\left(\frac{n}{\frac{4 C_{g_{i}}^{2} C_{\varphi_{i}}^{2} n L_{\bar{\varphi}_{i}}^{2}(m+1)^{2} 2^{2 m}}{\varepsilon}}\right)^{\frac{1}{2}}  \tag{98}\\
& =\frac{\varepsilon_{g_{i}} C_{\bar{\varphi}_{i}}(m+1) 2^{m}}{} .
\end{align*}
$$

Converting to homogeneous approximations. For $i \in[m]$, we write $B_{i}^{\left(d_{i}\right)}=$ $\sum_{j=0}^{n d_{i}} h_{i}^{(j)}$ such that $h_{i}^{(j)}$ is a homogeneous polynomial with $\operatorname{deg}\left(h_{i}^{(j)}\right)=j$. Set $p_{i}:=$ $\frac{1}{2}\left[B_{i}^{\left(d_{i}\right)}(x)+B_{i}^{\left(d_{i}\right)}(-x)\right]$, for $i \in[m]$. Then $p_{i}=\sum_{t=0}^{n u_{i}} h_{i}^{(2 t)}$, for $i \in[m]$, since $h_{i}^{(j)}(x)=$ $h_{i}^{(j)}(-x)$ if $j$ is even and $h_{i}^{(j)}(x)=-h_{i}^{(j)}(-x)$ otherwise. Since $\bar{\varphi}_{i}$ is even, $\bar{\varphi}_{i}(x)=$ $\frac{1}{2}\left[\bar{\varphi}_{i}(x)+\bar{\varphi}_{i}(-x)\right]$. It implies that for $x \in[-1,1]^{n}$, for $i \in[m]$,

$$
\begin{align*}
\left|p_{i}(x)-\bar{\varphi}_{i}(x)\right| & =\left|\frac{1}{2}\left[B_{i}^{\left(d_{i}\right)}(x)+B_{i}^{\left(d_{i}\right)}(-x)\right]-\frac{1}{2}\left[\bar{\varphi}_{i}(x)+\bar{\varphi}_{i}(-x)\right]\right| \\
& \leq \frac{1}{2}\left|B_{i}^{\left(d_{i}\right)}(x)-\bar{\varphi}_{i}(x)\right|+\frac{1}{2}\left|B_{i}^{\left(d_{i}\right)}(-x)-\bar{\varphi}_{i}(-x)\right|  \tag{99}\\
& \leq \frac{\varepsilon}{4 C_{g_{i}} C_{\bar{\phi}_{i}}(m+1) 2^{m}}+\frac{\varepsilon}{4 C_{g_{i}} C_{\bar{\varphi}_{i}}(m+1) 2^{m}}=\frac{\varepsilon}{2 C_{g_{i}} C_{\bar{\varphi}_{i}}(m+1) 2^{m}}
\end{align*}
$$

and

$$
\begin{equation*}
\left|p_{i}(x)\right| \leq \frac{1}{2}\left(\left|B_{i}^{\left(d_{i}\right)}(x)\right|+\left|B_{i}^{\left(d_{i}\right)}(x)\right|\right) \leq \frac{1}{2}\left(C_{\bar{\varphi}_{i}}+C_{\bar{\varphi}_{i}}\right)=C_{\bar{\varphi}_{i}} \tag{100}
\end{equation*}
$$

Set $q_{i}:=\sum_{t=0}^{n u_{i}} h_{i}^{(2 t)}\|x\|_{2}^{2\left(n u_{i}-t\right)}$. Then $q_{i}$ is a homogeneous polynomial of degree $2 n u_{i}$ and $q_{i}=p_{i}$ on $\mathbb{S}^{n-1}$, for $i \in[m]$. Thus for $i \in[m],\left|q_{i}(x)-\bar{\varphi}_{i}(x)\right| \leq \frac{\varepsilon}{2 C_{g_{i}} C_{\bar{\varphi}_{i}}(m+1) 2^{m}}$ and $\left|q_{i}(x)\right| \leq C_{\bar{\varphi}_{i}}$, for all $x \in \mathbb{S}^{n-1}$. From these and (93), for all $x \in \mathbb{S}^{n-1}$,

$$
\begin{align*}
& f(x)+\varepsilon-\sum_{i=1}^{m} q_{i}(x)^{2} g_{i}(x) \\
&= f(x)+\varepsilon-\sum_{i=1}^{m} \bar{\varphi}_{i}(x)^{2} g_{i}(x)+\sum_{i=1}^{m} g_{i}(x)\left[\bar{\varphi}_{i}(x)^{2}-q_{i}(x)^{2}\right] \\
& \geq \frac{\varepsilon}{2 m}-\sum_{i=1}^{m}\left|g_{i}(x)\right|\left|\bar{\varphi}_{i}(x)+q_{i}(x)\right|\left|\overline{\varphi_{i}}(x)-q_{i}(x)\right| \\
& \geq \frac{\varepsilon}{2^{m}}-\sum_{i=1}^{m} C_{g_{i}(x)}\left(\left|\bar{\varphi}_{i}(x)\right|+\left|q_{i}(x)\right|\right) \overline{2 C_{g_{i}} C_{\bar{\varphi}_{i}}(m+1) 2^{m}}  \tag{101}\\
& \geq \frac{\varepsilon}{2^{m}}-\sum_{i=1}^{m} 2 C_{g_{i}} C_{\bar{\varphi}_{i} \overline{ } \overline{2 C_{g_{i}} C_{\bar{\varphi}}} \frac{\varepsilon}{(m+1) 2^{m}}}=\frac{\varepsilon}{2^{m}}-\frac{m \varepsilon}{(m+1) 2^{m}}=\frac{\varepsilon}{(m+1) 2^{m}} .
\end{align*}
$$

Moreover, for all $x \in \mathbb{S}^{n-1}$,

$$
\begin{equation*}
f(x)+\varepsilon-\sum_{i=1}^{m} q_{i}(x)^{2} g_{i}(x) \leq C_{f}+\varepsilon+\sum_{i=1}^{m} C_{\varphi_{i}}^{2} C_{g_{i}}=: C_{F} . \tag{102}
\end{equation*}
$$

### 3.4.3 Applying the global positivity certificate

Set $D:=\max _{i \in[m]}\left\{2 n u_{i}+d_{g_{i}}, d_{f}\right\}$ and

$$
\begin{equation*}
F=\|x\|_{2}^{2\left(D-d_{f}\right)}\left(f+\varepsilon\|x\|_{2}^{2 d_{f}}\right)-\sum_{i=1}^{m} g_{i} q_{i}^{2}\|x\|_{2}^{2\left(D-2 n u_{i}-d_{g_{i}}\right)} . \tag{103}
\end{equation*}
$$

Then $F$ is a homogeneous polynomial of degree $2 D$ and for all $x \in \mathbb{S}^{n-1}$,

$$
\begin{equation*}
C_{F} \geq F(x)=f(x)+\varepsilon-\sum_{i=1}^{m} q_{i}(x)^{2} g_{i}(x) \geq \frac{\varepsilon}{(m+1) 2^{m}} . \tag{104}
\end{equation*}
$$

It implies that $F$ is a positive definite form of degree $2 D$ with $\inf _{x \in \mathbb{S}^{n-1}} F(x) \geq$ $\frac{\varepsilon}{(m+1) 2^{m}}$ and $\sup _{x \in \mathbb{S}^{n-1}} F(x) \leq C_{F}$. There is no loss of generality in assuming $C_{F}=$ $b \varepsilon^{-b}$ for some large enough $b>0$ independent of $\varepsilon$. Similarly assume that $D \geq d \varepsilon^{-d}$ for some large enough $d>0$ independent of $\varepsilon$. From this,

$$
\begin{equation*}
\Theta(F) \leq \frac{b \varepsilon^{-b}}{\frac{\varepsilon}{(m+1) 2^{m}}}=b(m+1) 2^{m} \varepsilon^{-b-1} . \tag{105}
\end{equation*}
$$

Set

$$
\begin{equation*}
\bar{K}:=\frac{2 n d \varepsilon^{-d}\left(2 d \varepsilon^{-d}-1\right)}{4 \log 2} b(m+1) 2^{m} \varepsilon^{-b-1} . \tag{106}
\end{equation*}
$$

Then

$$
\begin{equation*}
\bar{K} \geq \frac{2 n D(2 D-1)}{4 \log 2} \Theta(F)-\frac{n+2 D}{2} . \tag{107}
\end{equation*}
$$

Clearly there exist positive constants $\bar{c}$ and $c$ independent of $\varepsilon$ such that $\bar{c} \varepsilon^{-c} \geq \bar{K}$. Let $K \in \mathbb{N}$ and $K \geq \bar{c} \varepsilon^{-c} \geq \bar{K}$. According to Lemma 8 , there exists a homogeneous SOS polynomial $s_{0}$ of degree $2(D+K)$ such that $\|x\|_{2}^{2 K} F=s_{0}$. It implies that

$$
\begin{align*}
\|x\|_{2}^{2\left(D-d_{f}+K\right)}\left(f+\varepsilon\|x\|_{2}^{2 d_{f}}\right) & =s_{0}+\sum_{i=1}^{m} g_{i} q_{i}^{2}\|x\|_{2}^{2\left(D-2 n u_{i}-d_{g_{i}}+K\right)}  \tag{108}\\
& =s_{0}+\sum_{i=1}^{m} g_{i} s_{i}
\end{align*}
$$

where $s_{i}:=q_{i}^{2}\|x\|_{2}^{2\left(D-2 n u_{i}-d_{g_{i}}+K\right)}$ is a homogeneous SOS polynomial such that $\operatorname{deg}\left(g_{i} s_{i}\right)=$ $2(K+D)$, for $i \in[m]$. Set $k=D-d_{f}+K$. Then $\|x\|_{2}^{2 k}\left(f+\varepsilon\|x\|_{2}^{2 d_{f}}\right)=s_{0}+\sum_{i=1}^{m} g_{i} s_{i}$ with $\operatorname{deg}\left(s_{0}\right)=\operatorname{deg}\left(g_{i} s_{i}\right)=2\left(k+d_{f}\right)$, for $i \in[m]$.

The case of the ice cream constraint. Assume that $m=1$ and $g_{1}=x_{n}^{2}-\left\|x^{\prime}\right\|_{2}^{2}$ with $x^{\prime}:=\left(x_{1}, \ldots, x_{n-1}\right)$. We shall show that $c=65$. Using Lemma 3, we can take $\alpha_{m}=2$ in (65). We then obtain the following asymptotic equivalences as $\varepsilon \rightarrow 0^{+}$:

\begin{align*}
& \delta_{m} \sim R_{1} \varepsilon^{2} \Rightarrow C_{\psi_{m}} \sim R_{2} \varepsilon^{-2} \Rightarrow C_{\varphi_{m}} \sim R_{3} \varepsilon^{-1} \Rightarrow w_{m} \sim R_{4} \varepsilon^{5} \Rightarrow L_{\varepsilon_{\varepsilon_{m}}} \sim R_{5} \varepsilon^{-\frac{9}{2}} \\
& \Rightarrow L_{\bar{\varphi}_{m}} \sim R_{6} \varepsilon^{-6} \Rightarrow C_{\bar{\varphi}_{m}} \sim R_{7} \varepsilon^{-6} \Rightarrow u_{m} \sim R_{8} \varepsilon^{-26} \Rightarrow d_{m} \sim R_{9} \varepsilon^{-26} \\
& \Rightarrow C_{F} \sim R_{10} \varepsilon^{-12} \Rightarrow D \sim R_{11} \varepsilon^{-26} \Rightarrow b=12 \Rightarrow d=26 \Rightarrow \bar{K} \sim R_{12} \varepsilon^{-65} \\
& \Rightarrow c=65 . \tag{109}
\end{align*}
$$

for some $R_{j}>0$ independent of $\varepsilon, j \in[12]$. This completes the proof of Theorem 2 .

## 4 Polynomial optimization

This section is concerned with some applications to polynomial optimization. Consider the following POP:

$$
\begin{equation*}
f^{\star}:=\inf _{x \in S} f(x), \tag{110}
\end{equation*}
$$

where $f \in \mathbb{R}[x]$ and

$$
\begin{equation*}
S=\left\{x \in \mathbb{R}^{n}: g_{j}(x) \geq 0, j \in[m]\right\}, \tag{111}
\end{equation*}
$$

for some $g_{j} \in \mathbb{R}[x], j \in[m]$. Recall that $\theta=1+\|x\|_{2}^{2}$.

### 4.1 General case

In this subsection, we improve the convergence rate of the Moment-SOS hierarchy described in [9, Theorem 4.3], based on Putinar-Vasilescu's Positivstellensatz [17].

Theorem 3. Let $f, g_{1}, \ldots, g_{m}$ be polynomials such that $f^{\star}$ defined as in (110) and $S$ defined as in (111) satisfy that $S$ has nonempty interior and $f^{\star}>-\infty$. Let $\varepsilon>0$ and denote $g_{0}:=1$. Let $d_{f}:=\lfloor\operatorname{deg}(f) / 2\rfloor+1$ and $d_{g_{j}}:=\left\lceil\operatorname{deg}\left(g_{j}\right) / 2\right\rceil, j \in\{0\} \cup[m]$. Consider the hierarchy of semidefinite programs indexed by $k \in \mathbb{N}$ :

$$
\begin{align*}
\tau_{k}^{(\varepsilon)}:=\inf & L_{y}\left(\theta^{k}\left(f+\varepsilon \theta^{d_{f}}\right)\right) \\
\text { s.t. } & y=\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}_{2\left(d_{f}+k\right)}} \subset \mathbb{R}, \\
& M_{k+d_{f}}(y) \succeq 0,  \tag{112}\\
& M_{k+d_{f}-d_{g_{j}}}\left(g_{j} y\right) \succeq 0, j \in[m], \\
& L_{y}\left(\theta^{k}\right)=1 .
\end{align*}
$$

For every $k \in \mathbb{N}$, the dual of (112) reads as:

$$
\begin{equation*}
\rho_{k}^{(\varepsilon)}:=\sup _{\lambda \in \mathbb{R}}\left\{\lambda: \theta^{k}\left(f-\lambda+\varepsilon \theta^{d_{f}}\right) \in \mathcal{Q}_{k+d_{f}}\right\}, \tag{113}
\end{equation*}
$$

where $\mathcal{Q}_{r}$ is defined as in (15). The following statements hold:

1. For all $k \in \mathbb{N}$,

$$
\begin{equation*}
\rho_{k}^{(\varepsilon)} \leq \rho_{k+1}^{(\varepsilon)} \leq f^{\star} \tag{114}
\end{equation*}
$$

2. Assume that problem (110) has an optimal solution $x^{\star}$. Then there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for all $k \geq \bar{c} \varepsilon^{-c}$,

$$
\begin{equation*}
0 \leq \rho_{k}^{(\varepsilon)}-f^{\star} \leq \varepsilon \theta\left(x^{\star}\right)^{d_{f}} \tag{115}
\end{equation*}
$$

3. Strong duality holds for all orders $k$ of the primal-dual problems (112)-(113).

The proof of Theorem 3 is exactly the same as the proof of [9, Theorem 7]. The second statement relies on Corollary 1. The third statement is due to the Slater condition [24, Theorem 3.1] since $S$ has nonempty interior (see in detail [9, Proposition 2 and Remark 3]).

### 4.2 Compact case

In this subsection, we consider the case when $S$ is compact by assuming that a ball constraint is present. We can then remove the perturbation term $\varepsilon \theta^{d_{f}}$ in the hierarchy based on Putinar-Vasilescu's Positivstellensatz, described in the previous subsection.

Theorem 4. Let $f, g_{1}, \ldots, g_{m}$ be polynomials such that $f^{\star}$ defined as in (110) and $S$ defined as in (111) satisfy that $S$ has nonempty interior and $f^{\star}>-\infty$. Denote $g_{0}:=1$. Let $d_{f}:=\lfloor\operatorname{deg}(f) / 2\rfloor+1$ and $d_{g_{j}}:=\left\lceil\operatorname{deg}\left(g_{j}\right) / 2\right\rceil, j \in\{0\} \cup[m]$. Assume that $g_{1}=L-\|x\|_{2}^{2}$ for some $L>0$. Consider the hierarchy of semidefinite programs indexed by $k \in \mathbb{N}$ :

$$
\begin{align*}
\tau_{k}^{(0)}:=\inf & L_{y}\left(\theta^{k} f\right) \\
\text { s.t. } & y=\left(y_{\alpha}\right)_{\alpha \in \mathbb{N}_{2\left(d_{f}+k\right)}^{n}} \subset \mathbb{R}, \\
& M_{k+d_{f}}(y) \succeq 0,  \tag{116}\\
& M_{k+d_{f}-d_{g_{j}}}\left(g_{j} y\right) \succeq 0, j \in[m] \\
& L_{y}\left(\theta^{k}\right)=1
\end{align*}
$$

For every $k \in \mathbb{N}$, the dual of (116) reads as:

$$
\begin{equation*}
\rho_{k}^{(0)}:=\sup _{\lambda \in \mathbb{R}}\left\{\lambda: \theta^{k}(f-\lambda) \in \mathcal{Q}_{k+d_{f}}\right\} \tag{117}
\end{equation*}
$$

where $\mathcal{Q}_{r}$ is defined as in (15). The following statements hold:

1. For all $k \in \mathbb{N}$,

$$
\begin{equation*}
\rho_{k}^{(0)} \leq \rho_{k+1}^{(0)} \leq f^{\star} \tag{118}
\end{equation*}
$$

2. There exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that

$$
\begin{equation*}
0 \leq f^{\star}-\rho_{k}^{(0)} \leq\left(\frac{\bar{c}}{k}\right)^{\frac{1}{c}} \tag{119}
\end{equation*}
$$

3. Strong duality holds for all orders $k$ of the primal-dual problems (116)-(117).

Proof. The first and third statements of Theorem 4 can be proved similarly to the ones of Theorem 3. Let us prove the second statement. By using Corollary 2, there exist positive constants $\bar{c}$ and $c$ depending on $f, g_{1}, \ldots, g_{m}$ such that for any $\varepsilon>0$, for all $k \geq \bar{c} \varepsilon^{-c}$,

$$
\begin{equation*}
\theta^{k}\left(f-f^{\star}+\varepsilon\right) \in \mathcal{Q}_{k+d_{f}} \tag{120}
\end{equation*}
$$

Let $K \in \mathbb{N}$. Set $\epsilon=\left(\frac{\bar{c}}{K}\right)^{\frac{1}{c}}$. Then $\epsilon>0$ and $K=\bar{c} \epsilon^{-c}$, so that

$$
\begin{equation*}
\theta^{K}\left(f-f^{\star}+\epsilon\right) \in \mathcal{Q}_{K+d_{f}} \tag{121}
\end{equation*}
$$

It implies that $f^{\star}-\epsilon$ is a feasible solution of (117) with relaxation order $K$, yielding

$$
\begin{equation*}
0 \leq f^{\star}-\rho_{K}^{(0)} \leq f^{\star}-\left(f^{\star}-\epsilon\right)=\epsilon=\left(\frac{\bar{c}}{K}\right)^{\frac{1}{c}} \tag{122}
\end{equation*}
$$

Hence the desired result follows.

Remark 3. The authors' bounds in Theorems 3 and 4 are only for worst cases. In fact, for generic cases of polynomials, the Moment-SOS hierarchy based on Putinar's Positivstellensatz (in [8]) has finite convergence [10].

## 5 Conclusion

We have provided a new degree bound on the sum-of-squares (SOS) polynomials involved in Putinar-Vasilescu's Positivstellensatz. The Moment-SOS hierarchy of semidefinite relaxations based on this Positivstellensatz provide a sequence of lower bounds on the minimum of a polynomial on a basic compact semialgebraic set. Moreover, this sequence of lower bounds converges to the minimum with the rate $\mathcal{O}\left(\varepsilon^{-c}\right)$, at prescribed accuracy $\varepsilon>0$. We emphasize that our result yields better convergence rates than the previous rate $\mathcal{O}\left(\exp \left(\varepsilon^{-c}\right)\right)$ one by Nie and Schweighofer [11] for Putinar's Positivstellensatz, at the price of making stronger assumptions, namely that the set of constraints has nonempty interior and involves a ball constraint, and denominators are used.

A topic of further investigation is the analysis of the convergence rate of the Moment-SOS hierarchy for lower bounds in some special cases of basic (compact) semialgebraic sets. A fairly straightforward idea is to find the explicit constant $\alpha$ in the Łojasiewicz inequality stated in Lemma 2. We could then proceed analogously to the proof of the rate $\mathcal{O}\left(\varepsilon^{-65}\right)$ for the minimization of a polynomial on the unit ball.
