## ON A PARTICULAR EXTENSION OF THE CHRISTOFFEL FUNCTION

#### 1. Introduction

A certain variant of the Christoffel function (see below) allows to relate to the underlying density without scaling factor. This variant considers balls  $\mathbf{B}(\boldsymbol{\xi}, \delta)$  around each point  $\boldsymbol{\xi} \in \operatorname{supp}(\mu)$ , as also do people in topological data analysis (see the interesting paper [1]).

A preliminary result. Let  $\Omega \subset \mathbb{R}^d$  be compact with nonempty interior and such that  $\Omega = \overline{\operatorname{int}(\Omega)}$ .

**Lemma 1.1.** Let  $\phi, \psi \in \mathcal{M}(\Omega)_+$  be two finite Borel measures on  $\Omega$  with  $\mathbf{M}_n(\phi), \mathbf{M}_n(\psi) \succ 0$  for all  $n \in \mathbb{N}$ . Let  $\lambda > 0$  be such that  $\mathbf{M}_n(\psi) \preceq \lambda \mathbf{M}_n(\phi)$  for all  $n \in \mathbb{N}$ . Then  $\psi \leq \lambda \phi$  and there exists  $0 \leq h \in L^{\infty}(\Omega, \phi)$  such that

$$(1.1) d\psi = h(\mathbf{x}) d\phi \quad and \quad ||h||_{\infty} \le \lambda.$$

Moreover,

(1.2) 
$$||h||_{\infty} = \inf_{\lambda} \{ \lambda : \mathbf{M}_n(\psi) \leq \lambda \mathbf{M}_n(\phi), \quad \forall n \in \mathbb{N} \}.$$

### 2. Main result

Let  $\mu$  be a finite Borel probability measure on  $\Omega$  with density  $f \in L^{\infty}(\Omega)$ , i.e.,  $d\mu = f(\mathbf{x}) 1_{\Omega}(\mathbf{x}) d\mathbf{x}$  and  $\int_{\Omega} f(\mathbf{x}) d\mathbf{x} = 1$ .

Next, given  $\boldsymbol{\xi} \in \mathbb{R}^d$  let  $\mathbf{B}(\boldsymbol{\xi}; \delta) := \{\mathbf{x} \in \mathbb{R}^d : \|\mathbf{x} - \boldsymbol{\xi}\| \leq \delta\}$ , and let  $d\phi_{\boldsymbol{\xi}} = \frac{1}{\text{vol}(\mathbf{B}(\boldsymbol{\xi}, \delta))} 1_{\mathbf{B}(\boldsymbol{\xi}, \delta)} d\mathbf{x}$ . Given  $h \in L^{\infty}(\Omega)$  let  $\|h\|_{\infty}^{\boldsymbol{\xi}, \delta}$  be the infinity-norm on  $\Omega \cap \mathbf{B}(\boldsymbol{\xi}, \delta)$ .

Consider the extended Christoffel function:

(2.1) 
$$\Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) := \min_{p \in \mathbb{R}[\mathbf{x}]_n} \left\{ \int_{\mathbf{\Omega}} p^2 d\mu : \int_{\mathbf{B}(\boldsymbol{\xi}, \delta)} p^2 d\phi_{\boldsymbol{\xi}} = 1 \right\},$$

and observe that if  $\delta = 0$  then  $\Lambda_n^{\mu}(\phi_{\xi}) = \Lambda_n^{\mu}(\delta_{\xi})$  coincides with the standard Christoffel function  $\xi \mapsto \Lambda_n^{\mu}(\xi)$ .

**Lemma 2.1.** Let  $\Lambda_n^{\mu}(\phi_{\xi})$  be as in (2.1) and  $\xi \in \text{int}(\Omega)$ . Then:

(2.2) 
$$\Lambda_n^{\mu}(\phi_{\xi}) = \lambda_{\min}(\mathbf{M}_n(\mu), \mathbf{M}_n(\phi_{\xi})), \quad \forall n \in \mathbb{N}.$$

Equivalently:

(2.3) 
$$\Lambda_n^{\mu}(\phi_{\xi})^{-1} = \lambda_{\max}(\mathbf{M}_n(\phi_{\xi}), \mathbf{M}_n(\mu))$$
$$= \inf_{\lambda} \{ \lambda : \mathbf{M}_n(\phi_{\xi}) \leq \lambda \mathbf{M}_n(\mu) \} \leq \|f\|_{\infty}^{\xi, \delta},$$

and moreover,

(2.4) 
$$\lim_{n \to \infty} \Lambda_n^{\mu} (\phi_{\xi})^{-1} = \|f\|_{\infty}^{\xi, \delta}.$$

*Proof.* Observe that (2.1) reads

(2.5) 
$$\Lambda_n^{\mu}(\phi_{\boldsymbol{\xi},\delta}) = \min_{\mathbf{p} \in \mathbb{R}^{s(n)}} \{ \langle \mathbf{M}_n(\mu), \mathbf{p} \mathbf{p}^T \rangle : \langle \mathbf{M}_n(\phi_{\boldsymbol{\xi}}), \mathbf{p} \mathbf{p}^T \rangle = 1 \}.$$

By Barvinok [] the semidefinite relaxation

$$\theta := \min_{\mathbf{X} \succ 0} \{ \langle \mathbf{M}_n(\mu), \mathbf{X} \rangle : \langle \mathbf{M}_n(\phi_{\xi}), \mathbf{X} \rangle = 1 \},$$

of (2.5) has a rank-one optimal solution  $\mathbf{X}^* = \mathbf{q}\mathbf{q}^T \succeq 0$  for some  $\mathbf{q} \in \mathbb{R}^{s(n)}$ , and therefore  $\mathbf{x} \mapsto q(\mathbf{x}) := \mathbf{q}^T \mathbf{v}_n(\mathbf{x}) \in \mathbb{R}[\mathbf{x}]_n$  is an optimal solution of (2.1), which also yields  $\theta = \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}})$ . As  $0 \prec \mathbf{X} := \mathbf{I}/\text{trace}(\mathbf{M}_n(\phi_{\boldsymbol{\xi}}))$  is a feasible solution, Slater's condition holds and therefore by standard conic duality:

$$\Lambda_n^{\mu}(\phi_{\xi}) = \sup_{\lambda} \{ \lambda : \lambda \mathbf{M}_n(\phi_{\xi}) \leq \mathbf{M}_n(\mu) \} = \lambda_{\min}(\mathbf{M}_n(\mu), \mathbf{M}_n(\phi_{\xi})),$$

which yields (2.2) and also the two equalities in (2.3). To get the inequality just use Lemma 1.1.

Next by (2.3), the sequence  $(\Lambda_n^{\mu}(\phi_{\xi})^{-1})_{n\in\mathbb{N}}$  is monotone increasing and is bounded above. Therefore  $\lim_{n\to\infty} \Lambda_n^{\mu}(\phi_{\xi})^{-1} = \rho^*$  for some  $\rho^* \leq \|f\|_{\infty}^{\xi,\delta}$ . But then by construction,  $\mathbf{M}_n(\phi_{\xi}) \leq \rho^* \mathbf{M}_n(\mu)$  for all  $n \in \mathbb{N}$ , which implies  $\rho^* \geq \|f\|_{\infty}^{\xi,\delta}$ , and which in turn yields the desired result.

As an immediate consequence, we obtain the following result.

**Lemma 2.2.** For every  $n \in \mathbb{N}$  define:

(2.6) 
$$\Lambda_n^{\mu}(\phi_{\xi}) := \min_{p \in \mathbb{R}[\mathbf{x}]_n} \{ \int_{\Omega} p^2 d\mu : \int_{\mathbf{B}(\xi, 1/n)} p^2 d\phi_{\xi} = 1 \}.$$

If f is piecewise continuous and  $\boldsymbol{\xi} \in \operatorname{int}(\Omega)$  is not a point of discontinuity then:

(2.7) 
$$\liminf_{n \to \infty} \Lambda_n^{\mu}(\phi_{\xi}) \ge \frac{1}{f(\xi)}.$$

*Proof.* If  $\boldsymbol{\xi} \in \operatorname{int}(\boldsymbol{\Omega})$  then  $\mathbf{B}(\boldsymbol{\xi}, 1/n) \subset \operatorname{int}(\boldsymbol{\Omega})$  provided that n is sufficiently large, say  $n \geq n_0$ . So let  $\Lambda_n^{\mu}(\boldsymbol{\xi})$  be as in (2.6) with  $n \geq n_0$ . If f is not a point of discontinuity then  $||f||_{\infty}^{\boldsymbol{\xi}, 1/n} \downarrow f(\boldsymbol{\xi})$  as n increases. Moreover by (2.3):

$$\limsup_{n\to\infty} \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}})^{-1} \leq \limsup_{n\to\infty} \|f\|_{\infty}^{\boldsymbol{\xi},1/n} = f(\boldsymbol{\xi}),$$

which yields the desired result (2.7).

In topological data analysis, they analyze clouds  $\mathcal{N}$  of finitely many points by approximating the cloud with  $\bigcup_{\boldsymbol{\xi} \in \mathcal{N}} \mathbf{B}(\boldsymbol{\xi}, \varepsilon)$ .

Notice that from KKT-optimality conditions, an optimal solution **p** of (2.1) satisfies:  $\mathbf{M}_n(\mu) \mathbf{p} = \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) \mathbf{M}_n(\phi_{\boldsymbol{\xi}}) \mathbf{p}$  and so

$$\mathbf{p} = \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) \, \mathbf{M}_n(\mu)^{-1} \int_{\mathbf{\Omega}} \mathbf{v}_n(\mathbf{y}) \underbrace{\mathbf{v}_n(\mathbf{y})^T \mathbf{p}}_{=p(\mathbf{y})} \, d\phi_{\boldsymbol{\xi}}(\mathbf{y}).$$

and using  $\mathbf{v}_n(\mathbf{x})^T \mathbf{M}_n(\mu)^{-1} \mathbf{v}_n(\mathbf{y}) = \sum_{\alpha} P_{\alpha}(\mathbf{x}) P_{\alpha}(\mathbf{y})$ , yields:

$$\mathbf{x} \mapsto p(\mathbf{x}) = \mathbf{v}_n(\mathbf{x})^T \mathbf{p} = \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) \sum_{\alpha \in \mathbb{N}_n^d} P_{\alpha}(\mathbf{x}) \int_{\mathbf{B}(\boldsymbol{\xi}, \delta)} P_{\alpha}(\mathbf{y}) \, p(\mathbf{y}) \, d\phi_{\boldsymbol{\xi}}(\mathbf{y}).$$

$$= \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) \int_{\mathbf{B}(\boldsymbol{\xi}, \delta)} \sum_{\alpha \in \mathbb{N}_n^d} P_{\alpha}(\mathbf{x}) \, P_{\alpha}(\mathbf{y}) \, p(\mathbf{y}) \, d\phi_{\boldsymbol{\xi}}(\mathbf{y})$$

$$= \Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}}) \int_{\mathbf{B}(\boldsymbol{\xi}, \delta)} K(\mathbf{x}, \mathbf{y}) \, p(\mathbf{y}) \, d\phi_{\boldsymbol{\xi}}(\mathbf{y})$$

So the optimal solution  $p \in \mathbb{R}[\mathbf{x}]_n$  is reproduced by the kernel  $K(\mathbf{x}, \mathbf{y})$  on  $\mathbf{B}(\boldsymbol{\xi}, \delta)$  (whereas K is a RKHS on  $L^2(\mu)$  (and not on  $L^2(\phi_{\boldsymbol{\xi}})$ ). Moreover:

$$\Lambda_n^{\mu}(\phi_{\boldsymbol{\xi}})^{-1} = \sum_{\alpha \in \mathbb{N}_n^d} \left( \int_{\mathbf{B}(\boldsymbol{\xi}, \delta)} P_{\alpha}(\mathbf{y}) \, p(\mathbf{y}) \, d\phi_{\boldsymbol{\xi}}(\mathbf{y}) \right)^2,$$

which coincides with  $\Lambda_n^{\mu}(\xi)^{-1} = K(\xi, \xi)$  when  $\phi_{\xi} = \delta_{\xi}$  (as then  $p(\xi) = 1$ ).
